- 3 [(m)] (O) "Registered seller" means an individual registered to provide burial goods as a sole proprietor or on behalf of a sole proprietor or of a permit holder.
- 5 **[**(n)**] (P)** "Registration" means a registration issued by the Director authorizing an individual to operate a cemetery or to provide burial goods.

 13 SUBJECT TO THE PROVISIONS OF THIS TITLE SHALL BEGIN CONSTRUCTION OR

- 16 **(B)** WITHIN 5 YEARS AFTER THE DATE OF THE FIRST SALE OF SPACE IN

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act applies to all sales of space in undeveloped garden crypts and mausoleum crypt sections made after the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2007.
