A BILL ENTITLED

1 AN ACT concerning

2 **Election Law – Board of Elections Members – Montgomery County**

3 **MC 704–07**

4 FOR the purpose of altering the number of members of the Montgomery County Board
5 of Elections; requiring that a certain number of regular members and substitute
6 members belong to certain parties; making a technical correction; and generally
7 relating to members of the Montgomery County Board of Elections.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Election Law**

2 (b) (1) Except as provided in [subsection] **SUBSECTIONS (j) AND (k)** of
3 this section, each local board consists of three regular members and two substitute
4 members.

5 (2) Two regular members and one substitute member shall be of the
6 majority party, and one regular member and one substitute member shall be of the
7 principal minority party.

8 (3) In the event of the absence of a regular member or a vacancy in the
9 office of a regular member, the substitute member of the same political party shall
10 exercise the powers and duties of a regular member until the regular member returns
11 or the vacancy is filled as prescribed in subsection (h) of this section.

12 (h) (1) **[If] EXCEPT AS PROVIDED IN SUBSECTIONS (J) AND (K) OF**
13 **THIS SECTION, IF** a member of a local board dies, resigns, is removed, or becomes
14 ineligible:

15 (i) the substitute member belonging to the same political party
16 shall become a regular member of the local board; and

17 (ii) the Governor shall appoint an eligible person from the same
18 political party to be the new substitute member.

19 (2) If a substitute member of a local board becomes a regular member
20 as provided in paragraph (1)(ii) of this subsection, dies, resigns, is removed, or
21 becomes ineligible when the confirming legislative body is not in session, the Governor
22 shall appoint an eligible person from the same political party as the predecessor
23 substitute member to fill the vacancy. That individual shall serve until the earlier of:

24 (i) the adjournment of the next session of the General
25 Assembly; or

26 (ii) the appointment of another individual to fill the same
27 vacancy.

28 **(K) (1) IN MONTGOMERY COUNTY, THE LOCAL BOARD CONSISTS OF**
29 **FIVE REGULAR MEMBERS AND TWO SUBSTITUTE MEMBERS.**

1 **(2) THREE REGULAR MEMBERS AND ONE SUBSTITUTE MEMBER**
2 **SHALL BE OF THE MAJORITY PARTY, AND TWO REGULAR MEMBERS AND ONE**
3 **SUBSTITUTE MEMBER SHALL BE OF THE PRINCIPAL MINORITY PARTY.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2007.
