19–201. In this subtitle the following words have the meanings indicated. (a) "Additional optional coverage" means a coverage or service that covers (b) the structures, contents, property, or activities on property that is available for purchase in connection with a standard homeowner's insurance policy. "COASTAL AREA" MEANS LAND AREA WITHIN 50 FEET OF THE (c) (1) STATE'S COASTAL WATERS. "COASTAL AREA" INCLUDES LAND AREA CONTIGUOUS TO AND **(2)** WITHIN 50 FEET OF: THE ATLANTIC OCEAN OR CHESAPEAKE BAY; AND **(I) (II)** MAJOR ESTUARIES OR STREAMS EMPTYING INTO THE ATLANTIC OCEAN OR CHESAPEAKE BAY. "Insurer" means an insurer that issues or delivers a policy of **(D)** homeowner's insurance in the State. **19–208**. AN INSURER SHALL PROVIDE COVERAGE BEYOND A COASTAL AREA. SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to all personal lines homeowner's insurance policies and contracts issued, delivered, or renewed on or after October 1, 2007. SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
