- 12 MARYLAND, That the Laws of Maryland read as follows:
- 13 **Article Natural Resources**
- 14 10–410.
- 15 (a) (1) Except as provided in paragraphs (2) and (3) of this subsection, a person may not hunt any game bird or mammal on Sundays.
- 17 (2) The following persons may hunt the specified game birds and 18 mammals on Sundays:
