- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 14 MARYLAND, That the Laws of Maryland read as follows:
- 15 Article Courts and Judicial Proceedings
- 16 11–107.
- (a) (1) Except as provided in § 11–106 of this subtitle AND PARAGRAPH
 (2) OF THIS SUBSECTION, the legal rate of interest on a judgment shall be at the rate
- 19 of 10 percent [per annum] A YEAR on the amount of judgment.

1 (2) THE LEGAL RATE OF INTEREST ON A MONEY JUDGMENT FOR 2 THE WASHINGTON SUBURBAN SANITARY COMMISSION SHALL BE AT THE RATE 3 OF THE WEEKLY AVERAGE 2-YEAR CONSTANT MATURITY TREASURY YIELD, AS 4 PUBLISHED BY THE BOARD OF GOVERNORS OF THE FEDERAL RESERVE 5 SYSTEM, FOR THE CALENDAR WEEK PRECEDING THE DATE OF THE ENTRY OF 6 JUDGMENT, COMPUTED DAILY TO THE DATE OF PAYMENT AND COMPOUNDED 7 ANNUALLY.

8 (b) The legal rate of interest on a money judgment for rent of residential 9 premises shall be at the rate of 6 percent [per annum] **A YEAR** on the amount of the 10 judgment.

11 (c) The legal rate of interest on a money judgment for delinquent real or 12 personal property taxes shall be the greater of:

(1) The sum of the rates fixed under §§ 14–603 and 14–702 of the Tax
 - Property Article for interest and penalties; or

(2) At the rate of 10 percent [per annum] **A YEAR**.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be 17 construed to apply only prospectively and may not be applied or interpreted to have 18 any effect on or application to any judgment of the Washington Suburban Sanitary 19 Commission entered before the effective date of this Act.

20 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
 21 October 1, 2007.
