## **Washington County - Fire Police Appointments**

3 FOR the purpose of authorizing the commanding officer to designate to the Sheriff of 4 Washington County, in a certain manner, a certain number of members of certain fire or ambulance companies to serve as fire police in Washington 5 County; requiring the Sheriff of Washington County to appoint certain 6 7 individuals to serve as fire police in Washington County; providing that certain 8 powers are granted to individuals appointed to serve as fire police in 9 Washington County; prohibiting individuals serving as fire police in 10 Washington County from using a weapon in the performance of certain duties; providing for the termination of members of certain fire or ambulance 11 companies who are serving as fire police in Washington County; providing that 12 individuals appointed to serve as fire police in Washington County receive 13 certain State benefits; repealing certain powers of a deputy sheriff in 14 Washington County; repealing certain provisions relating to pension and 15 retirement benefits for certain members of a fire company appointed as deputy 16 sheriffs; defining a certain term; and generally relating to fire police 17 18 appointments in Washington County.

9 10	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
11	Article - Public Safety

13 14	(a) This section applies only to Baltimore County, Caroline County, Cecil County, AND Queen Anne's County[, and Washington County].
15 16 17 18	(b) The sheriff of a county subject to this section may appoint as deputy sheriffs members of fire companies, whether volunteer, career, incorporated, or unincorporated, to exercise the powers of deputy sheriffs at fires and while going to and from fires.
19 20	(c) (1) The commanding officer may designate three members of the fire company to be appointed as deputy sheriffs.
21 22	(2) The commanding officer may be one of the three members designated under this subsection.
23 24 25	(d) (1) (i) Except in Caroline County, the sheriff of a county subject to this section shall appoint as deputy sheriff a member of the fire company designated under subsection (c) of this section on request of the designated member.
26 27	(ii) In Caroline County, the Sheriff of Caroline County may appoint the designated member as deputy sheriff.
28	(2) A request for appointment shall be accompanied by a written

certificate of designation signed by the commanding officer.

1 2 3	(e) (1) Except as provided in paragraphs (2) and (3) of this subsection, a member of a fire company appointed as deputy sheriff under this section may exercise the powers of deputy sheriffs at fires and while going to and from fires.
4 5 6	(2) The powers of members appointed as deputy sheriffs do not apply and may not be exercised in a municipal corporation that maintains an organized police force.
7 8 9	[(3) In Washington County, a member appointed as deputy sheriff has the powers necessary to perform the duties of deputy sheriffs while going to, functioning at, or returning from:
10	(i) fires;
11	(ii) accidents;
12	(iii) floods;
13	(iv) other emergencies; or
14	(v) other functions conducted by a fire company.]
15 16	(f) (1) The appointment of a member of a fire company as deputy sheriff terminates if the member ceases to be a member of the fire company.
17 18	(2) The sheriff of a county subject to this section may remove a member appointed as deputy sheriff at any time for just cause.
19 20 21	(3) If a member appointed as deputy sheriff dies, resigns, is dismissed, refuses to serve, or is unable to serve, the commanding officer may designate another member of the fire company to be appointed as deputy sheriff.
22 23 24 25	(4) (i) Except in Caroline County, if the commanding officer designates another member of the fire company to be appointed as deputy sheriff, the sheriff of the county shall appoint that member as deputy sheriff, subject to subsections (d) and (e) of this section.
26 27	(ii) In Caroline County, the Sheriff of Caroline County may appoint the designated member as deputy sheriff.
28	[(g) In Washington County, a member of a fire company appointed as deputy

sheriff under this section is deemed an appointed official and shall be treated as an

4	(A) IN THIS SECTION, "FIRE AND AMBULANCE COMPANY" MEANS A
5 6	VOLUNTEER, CAREER, INCORPORATED, OR UNINCORPORATED FIRE OR AMBULANCE COMPANY.
7	(B) THIS SECTION APPLIES ONLY TO WASHINGTON COUNTY.
8	(C) (1) (I) THE COMMANDING OFFICER MAY DESIGNATE TO THE
9 10	SHERIFF OF WASHINGTON COUNTY UP TO 20 INDIVIDUALS WHO ARE MEMBERS OF THE COMMANDING OFFICER'S FIRE OR AMBULANCE COMPANY TO BE
11	APPOINTED AS FIRE POLICE IN WASHINGTON COUNTY.
12	(II) A WRITTEN CERTIFICATE OF DESIGNATION SIGNED BY

- 8 (II) IN OTHER AREAS OF WASHINGTON COUNTY.

- 12 (E) (1) THE APPOINTMENT OF A MEMBER OF A FIRE OR AMBULANCE 13 COMPANY AS FIRE POLICE IN WASHINGTON COUNTY TERMINATES IF THE 14 MEMBER CEASES TO BE A MEMBER OF THE FIRE OR AMBULANCE COMPANY.
- 15 **(2)** THE SHERIFF OF WASHINGTON COUNTY MAY REMOVE A MEMBER APPOINTED AS FIRE POLICE AT ANY TIME.
- 17 (3) If a member appointed to serve as fire police in 18 Washington County dies, resigns, is dismissed, refuses to serve, or is 19 Unable to serve, the commanding officer may designate another 20 Member of the fire or ambulance company to be appointed as fire 21 Police.
- 22 (F) AN INDIVIDUAL APPOINTED TO SERVE AS FIRE POLICE IN
  23 WASHINGTON COUNTY UNDER THIS SECTION IS DEEMED AN APPOINTED
  24 OFFICIAL AND SHALL BE TREATED AS AN APPOINTED OFFICIAL FOR PURPOSES
  25 OF TITLE 22 AND TITLE 23 OF THE STATE PERSONNEL AND PENSIONS
  26 ARTICLE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2007.
