1 WHEREAS, Maryland has been greatly enriched by this diversity, and the 2 government should always take steps to promote the dignity of all the heritages that form this State's pluralistic society; and 3 4 WHEREAS, It is not the purpose of this Act nor may this Act be construed to 5 infringe on the rights of citizens to exercise the use of a language of their choice for 6 private conduct; now, therefore, 7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 8 MARYLAND, That the Laws of Maryland read as follows: 9 **Article – State Government** SUBTITLE 13. OFFICIAL LANGUAGE OF THE STATE OF MARYLAND. 10 10-1301. 11 (A) (1) ENGLISH IS RECOGNIZED AS THE OFFICIAL LANGUAGE OF 12 13 **GOVERNMENT OF THIS STATE.** (2) 14 AS THE OFFICIAL LANGUAGE OF THE STATE, ENGLISH IS THE LANGUAGE OF GOVERNMENT FUNCTIONS AND ACTIONS. 15 16 **(B)** THE PROVISIONS OF THIS SECTION APPLY TO: (1) THE LEGISLATIVE, EXECUTIVE, AND JUDICIAL BRANCHES OF 17 **GOVERNMENT; AND** 18 19 (2) STATE AND EACH POLITICAL SUBDIVISION AND THE MUNICIPAL CORPORATION OF THE STATE, INCLUDING EACH DEPARTMENT, 20 AGENCY, UNIT, ORGANIZATION, AND INSTRUMENTALITY THEREOF. 21 22 **(C)** AN ENTITY SUBJECT TO THE PROVISIONS OF THIS SECTION SHALL: 23 (1) WRITE AND PUBLISH EACH OFFICIAL DOCUMENT IN ENGLISH; 24 AND (2) 25 CONDUCT EACH MEETING AND OTHER OFFICIAL ORAL COMMUNICATION IT AUTHORIZES IN ENGLISH. 26

1 SECTION 2. AND BE IT FURTHER ENACTED, That if any provision of this 2 Act or the application thereof to any person or circumstance is held invalid for any 3 reason in a court of competent jurisdiction, the invalidity does not affect other 4 provisions or any other application of this Act which can be given effect without the 5 invalid provision or application, and for this purpose the provisions of this Act are 6 declared severable.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
October 1, 2007.
