FOR the purpose of requiring certain county boards of education to provide certain health benefits to certain retired employees; requiring certain county boards to develop and implement certain plans in consultation with certain associations; authorizing a county board of education to establish different cost-sharing ratios for certain individuals; and generally relating to health benefits for retired principals, teachers, and other certificated and noncertificated employees of a county board of education.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 16 MARYLAND, That the Laws of Maryland read as follows:

1 (A) A COUNTY BOARD SHALL PROVIDE HEALTH BENEFITS TO RETIRED 2 PRINCIPALS, TEACHERS, AND OTHER CERTIFICATED AND NONCERTIFICATED 3 EMPLOYEES OF THE COUNTY BOARD IN ACCORDANCE WITH SUBSECTION (B) OF 4 THIS SECTION.

5 (B) (1) IN CONSULTATION WITH A COUNTY ASSOCIATION FOR 6 RETIREES OF THE COUNTY BOARD, A COUNTY BOARD SHALL DEVELOP AND 7 IMPLEMENT A PLAN TO PROVIDE MEDICAL, DENTAL, VISION, AND 8 PRESCRIPTION BENEFITS TO THE INDIVIDUALS QUALIFIED UNDER SUBSECTION 9 (A) OF THIS SECTION IF IT HAS A PLAN TO PROVIDE THOSE HEALTH BENEFITS 10 TO CURRENT PRINCIPALS, TEACHERS, AND OTHER CERTIFICATED AND 11 NONCERTIFICATED EMPLOYEES OF THE COUNTY BOARD.

12(2) THE COUNTY BOARD MAY ESTABLISH DIFFERENT13COST-SHARING RATIOS FOR RETIREES AND FOR CURRENT EMPLOYEES.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2007.
