A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Medical Assistance Program – Atypical Antipsychotic Medication**

3 FOR the purpose of providing that certain Maryland Medical Assistance Program
4 enrollees who are prescribed certain medications shall be automatically
5 dispensed a certain supply of medication and may not be subject to a certain
6 waiting period; repealing a certain termination provision; repealing an
7 exemption from prior authorization for certain medications; making certain
8 technical corrections; and generally relating to the Maryland Medical
9 Assistance Program and atypical antipsychotic medication.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Health – General**

4 15–101.

5 (a) In this title the following words have the meanings indicated.

6 (h) “Program” means the Maryland Medical Assistance Program.

7 (i) “Program recipient” means an individual who receives benefits under the
8 Program.

9 15–119.

10 (a) (1) This section does not apply to drugs covered by managed care
11 organizations under § 15–103 of this subtitle.

12 (2) This section applies to the [Maryland Pharmacy Assistance
13 Program developed under § 15–124 of this subtitle, the Maryland Pharmacy Discount
14 Program developed under § 15–124.1 of this subtitle,] **PRIMARY ADULT CARE
15 PROGRAM** and any other pharmacy assistance program developed by the
16 Department.

17 (b) [Atypical antipsychotic medications shall be exempt from prior
18 authorization requirements under the Program] **PROGRAM RECIPIENTS WHO ARE
19 PRESCRIBED ATYPICAL ANTIPSYCHOTIC MEDICATIONS THAT ARE SUBJECT TO
20 PRIOR AUTHORIZATION UNDER THE PROGRAM:**

21 **(1) SHALL BE AUTOMATICALLY DISPENSED AN INITIAL 30–DAY
22 SUPPLY OF MEDICATION; AND**

23 **(2) MAY NOT BE SUBJECT TO A WAITING PERIOD TO DETERMINE
24 WHETHER PRIOR AUTHORIZATION WAS GIVEN.**

25 **Chapter 444 of the Acts of 2005**

26 [SECTION 41. AND BE IT FURTHER ENACTED, That Section 4 of this Act
27 shall remain effective for a period of 2 years and, at the end of June 30, 2007, with no

1 further action required by the General Assembly, Section 4 of this Act shall be
2 abrogated and of no further force and effect.]

3 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
4 July 1, 2007.
