Unclaimed Restitution – Disbursements and Use

3 FOR the purpose of requiring the Comptroller to distribute all unclaimed money from 4 certain judgments to the State Victims of Crime Fund for a certain purpose; 5 requiring the Comptroller to reduce a certain distribution by a certain amount if a victim entitled to certain restitution is located; requiring the State Board of 6 7 Victim Services to ensure that the money obtained from unclaimed restitution is 8 used for certain grants; providing that it is the intent of the General Assembly 9 that if certain funding is terminated or reduced below a certain level, the Governor shall include a certain appropriation in the annual budget bill; and 10

UNDER THIS PARAGRAPH, THE ADMINISTRATOR SHALL REDUCE THE NEXT DISTRIBUTION TO THE STATE VICTIMS OF CRIME FUND BY THE AMOUNT RECOVERED BY THE VICTIM.

4 [(3)](4) After making the [distribution] **DISTRIBUTIONS** required 5 under [paragraph (2)] **PARAGRAPHS (2)** AND (3) of this subsection, the 6 Administrator shall distribute the remaining net funds not retained under paragraph 7 (1) of this subsection to the General Fund of the State.

8 (b) Before making the distribution, the Administrator shall record the name 9 and last known address, if any, of the owners of funds so distributed and the type of 10 property which the funds distributed represent. The record shall be available for 11 public inspection during reasonable business hours by any person who claims a legal 12 interest in any property held by the Administrator, provided that the person gives 13 prior notice to the Administrator.

- 16 (a) There is a grant program.
- 17 (b) The Governor's Office of Crime Control and Prevention shall:
- 18 (1) adopt regulations for the administration and award of grants
 19 under Part II of this subtitle; and
- 20 (2) submit all approved grant applications to the Board.
- 21 (c) The Board shall:
- (1) approve each grant application received by the Governor's Office of
 Crime Control and Prevention before any money is released from the Fund; AND
- (2) ENSURE THAT THE MONEY OBTAINED FROM UNCLAIMED
 RESTITUTION UNDER § 11–614(B)(2) OF THIS TITLE IS USED FOR ANNUAL
 GRANTS TO PROVIDE LEGAL COUNSEL TO VICTIMS OF CRIMES AND DELINQUENT
 ACTS TO PROTECT THE VICTIMS' RIGHTS AS PROVIDED BY LAW.
- 28 SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the 29 General Assembly that if the funding provided to serve Maryland crime victims 30 through the Department of Justice's State and Federal Clinics and System

Demonstration Project and the Crime Victims' Rights Enforcement Project is terminated or reduced below a total of \$500,000 per fiscal year, the Governor shall include in the annual budget bill each year an appropriation to the State Victims of Grime Fund of \$500,000 less any funding provided by the federal projects and any

5 amount distributed to the Fund under the provisions of this Act.

6 SECTION 3. <u>2.</u> AND BE IT FURTHER ENACTED, That this Act shall take 7 effect October 1, 2007.
