A BILL ENTITLED

1 AN ACT concerning

2 **Home Improvement Contracts – Exception to Limit on Deposits**

3 FOR the purpose of authorizing a person to receive a deposit of more than one-third of
4 a home improvement contract price before or at the time of execution of the
5 home improvement contract if that person provides a certain bond or bond
6 equivalent and includes a certain notice in the home improvement contract; and
7 generally relating to an exception to the limit on deposits before or at the time
8 of execution of a home improvement contract.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Business Regulation**

17 8–617.

18 (a) A person may not demand or receive any payment for a home
19 improvement before the home improvement contract is signed.

1 (b) **[A] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, A**
2 person may not receive a deposit of more than one-third of the home improvement
3 contract price before or at the time of execution of the home improvement contract.

4 **(C) A PERSON ENGAGED IN THE BUSINESS OF MAKING RETAIL SALES IN**
5 **THE STATE MAY RECEIVE PAYMENT OF MORE THAN ONE-THIRD OF THE HOME**
6 **IMPROVEMENT CONTRACT BEFORE OR AT THE TIME OF EXECUTION OF THE**
7 **HOME IMPROVEMENT CONTRACT IF THE PERSON:**

8 **(1) PROVIDES:**

9 **(I) A PERFORMANCE AND PAYMENT BOND;**

10 **(II) A LIEN AND COMPLETION BOND; OR**

11 **(III) A BOND EQUIVALENT APPROVED BY THE COMMISSION**
12 **THAT GUARANTEES THE FULL PERFORMANCE AND COMPLETION OF A SIGNED**
13 **HOME IMPROVEMENT CONTRACT; AND**

14 **(2) INCLUDES IN THE HOME IMPROVEMENT CONTRACT CLEAR**
15 **AND CONSPICUOUS WRITTEN NOTICE THAT:**

16 **(I) THE CUSTOMER IS NOT REQUIRED TO PAY MORE THAN**
17 **ONE-THIRD OF THE HOME IMPROVEMENT CONTRACT PRICE BEFORE OR AT THE**
18 **TIME OF EXECUTION OF THE HOME IMPROVEMENT CONTRACT; AND**

19 **(II) IF THE CUSTOMER CHOOSES TO PAY MORE THAN**
20 **ONE-THIRD OF THE HOME IMPROVEMENT CONTRACT PRICE BEFORE OR AT THE**
21 **TIME OF EXECUTION OF THE HOME IMPROVEMENT CONTRACT, THE**
22 **CONTRACTOR WILL PROVIDE A BOND OR BOND EQUIVALENT TO ENSURE**
23 **COMPLETION OF THE HOME IMPROVEMENT CONTRACT.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 June 1, 2007.
