A BILL ENTITLED

1 AN ACT concerning

2 **Sales and Use Tax – Services**

3 FOR the purpose of altering the definition of “taxable service” under the sales and use
4 tax to impose the tax on certain services; and generally relating to the sales and
5 use taxation of certain services.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article – Tax – General**

14 11–101.

15 (m) “Taxable service” means:

16 (1) fabrication, printing, or production of tangible personal property by
17 special order;

- 1 (2) commercial cleaning or laundering of textiles for a buyer who is
2 engaged in a business that requires the recurring service of commercial cleaning or
3 laundering of the textiles;
- 4 (3) cleaning of a commercial or industrial building;
- 5 (4) cellular telephone or other mobile telecommunications service;
- 6 (5) “900”, “976”, “915”, and other “900”-type telecommunications
7 service;
- 8 (6) custom calling service provided in connection with basic telephone
9 service;
- 10 (7) a telephone answering service;
- 11 (8) pay per view television service;
- 12 (9) credit reporting;
- 13 (10) a security service, including:
- 14 (i) a detective, guard, or armored car service; and
- 15 (ii) a security systems service;
- 16 (11) a transportation service for transmission, distribution, or delivery
17 of electricity or natural gas, if the sale or use of the electricity or natural gas is subject
18 to the sales and use tax; [or]
- 19 (12) a prepaid telephone calling arrangement;
- 20 **(13) A TANNING FACILITY OR SERVICE;**
- 21 **(14) A TATTOO OR BODY PIERCING SERVICE;**
- 22 **(15) SWIMMING POOL OR HOT TUB CLEANING;**
- 23 **(16) A SELF-STORAGE FACILITY OR SERVICE;**
- 24 **(17) INTERIOR DECORATING; OR**

1 **(18) A HOME MOVING SERVICE.**

2 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
3 effect July 1, 2007.
