A BILL ENTITLED

1 AN ACT concerning

2 Maryland Transportation Authority - Susquehanna River Region E-Z Pass

- 3 FOR the purpose of requiring the Maryland Transportation Authority to provide for a Susquehanna River Region E-Z Pass that is valid only at the Thomas J. Hatem 4 5 Memorial Bridge and a certain portion of the John F. Kennedy Memorial Highway; providing for the purchase of a Susquehanna River Region E-Z Pass: 6 7 limiting use of the Susquehanna River Region E-Z Pass to certain types of 8 motor vehicles; requiring registration for the Susquehanna River Region E-Z 9 Pass and establishing certain registration procedures; establishing a maximum 10 fee for the Susquehanna River Region E-Z Pass; authorizing the Authority to adopt certain regulations; and generally relating to the use of a Susquehanna 11 River Region E-Z Pass on the Thomas J. Hatem Memorial Bridge and the John 12 F. Kennedy Memorial Highway. 13

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 20 MARYLAND, That the Laws of Maryland read as follows:

- 2 (A) (1) THE AUTHORITY SHALL PROVIDE FOR A SUSQUEHANNA
- 3 RIVER REGION E-Z PASS THAT IS VALID ONLY FOR THE THOMAS J. HATEM
- 4 MEMORIAL BRIDGE AND THAT PORTION OF THE JOHN F. KENNEDY MEMORIAL
- 5 HIGHWAY WITHIN CECIL COUNTY AND HARFORD COUNTY.

6 (2) THE AUTHORITY SHALL:

- 7 (I) PROVIDE THE SUSQUEHANNA RIVER REGION E-Z PASS
- 8 ONLY TO THOSE INDIVIDUALS PROPERLY REGISTERED UNDER THIS SECTION;
- 9 (II) ACCEPT THE SUSQUEHANNA RIVER REGION E-Z PASS
- 10 FOR TWO-AXLE VEHICLES ONLY AND MAY NOT ACCEPT THE DEVICE FOR
- 11 VEHICLES TOWING OTHER VEHICLES OR VEHICLES BEING TOWED; AND
- 12 (III) CHARGE NOT MORE THAN \$10 ANNUALLY FOR THE
- 13 SUSQUEHANNA RIVER REGION E-Z PASS PROVIDED UNDER THIS SECTION.
- 14 (3) THE SUSQUEHANNA RIVER REGION E-Z PASS SHALL BE
- 15 AVAILABLE FOR PURCHASE ONLY AT THE ADMINISTRATIVE OFFICES OF:
- 16 (I) CECIL COUNTY AND HARFORD COUNTY; AND
- 17 (II) THE MUNICIPALITIES WITHIN THE BORDERS OF CECIL
- 18 COUNTY AND HARFORD COUNTY.
- 19 (B) A PERSON MAY REGISTER FOR THE SUSQUEHANNA RIVER REGION
- 20 E-Z PASS UNDER THIS SECTION ONLY IF THE PERSON:
- 21 (1) SUBMITS AN APPLICATION AND REGISTERS TO PURCHASE
- 22 THE SUSQUEHANNA RIVER REGION E-Z PASS IN PERSON;
- 23 (2) Pays the \$10 annual fee required under this section;
- 24 **AND**
- 25 (3) PROVIDES ANY OTHER INFORMATION THAT MAY BE
- 26 **REQUIRED BY THE AUTHORITY.**

- 1 (C) THE AUTHORITY MAY ADOPT REGULATIONS TO CARRY OUT THIS 2 SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2007.
