- 3 FOR the purpose of reestablishing the Joint Committee on Unemployment Insurance 4 Oversight; establishing the membership and staffing of the Committee; requiring the President of the Senate and the Speaker of the House of Delegates 5 to designate the cochairs of the Committee; requiring the Committee to examine 6 7 certain issues; authorizing the Committee to examine certain issues; requiring 8 the Committee to issue a certain report by a certain date; prohibiting a member 9 of the Committee from receiving certain compensation, but authorizing a 10 member of the Committee to receive certain reimbursements; providing for the termination of this Act; and generally relating to the reestablishment of the 11 Joint Committee on Unemployment Insurance Oversight. 12

- 5 (B) THE COMMITTEE CONSISTS OF THE FOLLOWING 15 MEMBERS:
- 6 (1) THREE MEMBERS OF THE SENATE, APPOINTED BY THE 7 PRESIDENT OF THE SENATE;
- 8 (2) THREE MEMBERS OF THE HOUSE OF DELEGATES, APPOINTED BY THE SPEAKER OF THE HOUSE OF DELEGATES;
- 10 (3) THE SECRETARY OF LABOR, LICENSING, AND REGULATION, 11 OR THE SECRETARY'S DESIGNEE;
- 12 **(4)** THE SECRETARY OF BUSINESS AND ECONOMIC 13 DEVELOPMENT, OR THE SECRETARY'S DESIGNEE;

- 5 (D) THE PRESIDENT AND THE SPEAKER SHALL APPOINT A SENATOR 6 AND A DELEGATE, RESPECTIVELY, EACH TO SERVE AS COCHAIR.
- 7 (E) (1) THE COMMITTEE SHALL EXAMINE THE CONDITION OF THE 8 UNEMPLOYMENT INSURANCE SYSTEM IN THE STATE AS A RESULT OF THE 9 IMPLEMENTATION OF CHAPTER 169 OF THE ACTS OF THE GENERAL ASSEMBLY 10 OF 2005.
- 11 (2) THE COMMITTEE MAY EXAMINE THE NEED FOR ADDITIONAL
 12 ALTERATIONS TO THE UNEMPLOYMENT INSURANCE SYSTEM, INCLUDING THE
 13 CHARGING AND TAXATION PROVISIONS AND THE ELIGIBILITY AND BENEFIT
 14 PROVISIONS, IN CONSIDERATION OF THE FAIRNESS OF THE SYSTEM AND IN
 15 ORDER TO MAINTAIN THE UNEMPLOYMENT INSURANCE TRUST FUND AT A
 16 LEVEL SUFFICIENT TO ENSURE THAT BENEFITS WILL BE PAID FROM THE FUND.
- 17 (F) (1) THE DEPARTMENT OF LEGISLATIVE SERVICES SHALL 18 PROVIDE STAFFING FOR THE COMMITTEE.
- 19 (2) THE DEPARTMENT OF LABOR, LICENSING, AND REGULATION
 20 SHALL REPORT TO THE COMMITTEE ON THE CONDITION OF UNEMPLOYMENT
 21 INSURANCE IN THE STATE.
- 22 (G) A MEMBER OF THE COMMITTEE MAY NOT RECEIVE COMPENSATION
 23 FOR SERVING ON THE COMMITTEE, BUT IS ENTITLED TO REIMBURSEMENT FOR
 24 EXPENSES UNDER THE STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED
 25 IN THE STATE BUDGET.
- 26 (H) THE COMMITTEE SHALL REPORT ITS FINDINGS AND
 27 RECOMMENDATIONS TO THE GOVERNOR AND, SUBJECT TO § 2–1246 OF THE
 28 STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY ON DECEMBER 31 OF
 29 EACH YEAR.
