## A BILL ENTITLED

1 AN ACT concerning

2 **Public Health - Self-Injury by Cutting - Public Awareness Campaign**

3 FOR the purpose of requiring the State Superintendent of Schools, in collaboration  
4 with the Department of Health and Mental Hygiene, to establish and promote  
5 in certain schools a public awareness campaign related to self-injury by cutting;  
6 providing for the components of the campaign; authorizing the State  
7 Superintendent to use certain resources to carry out the provisions of this Act;  
8 and generally relating to a public awareness campaign about self-injury by  
9 cutting.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That the Laws of Maryland read as follows:

1                   (A) (1) THE STATE SUPERINTENDENT, IN COLLABORATION WITH THE  
2 DEPARTMENT OF HEALTH AND MENTAL HYGIENE, SHALL ESTABLISH AND  
3 PROMOTE IN SCHOOLS IN THE STATE A PUBLIC INFORMATION, AWARENESS,  
4 AND EDUCATION CAMPAIGN ON SELF-INJURY BY CUTTING.

5                   (2) THE CAMPAIGN SHALL:

6                   (I) REACH OUT TO STUDENTS AND THEIR PARENTS OR  
7 GUARDIANS, AND SPECIFIC POPULATIONS DETERMINED TO BE AT HIGH RISK  
8 FOR SELF-INJURY BY CUTTING;

9                   (II) DISSEMINATE THE INFORMATION ABOUT SELF-INJURY  
10 BY CUTTING THROUGH WRITTEN MATERIALS, TELEVISION, POSTERS, OR ANY  
11 OTHER MEDIUM THE STATE SUPERINTENDENT CONSIDERS APPROPRIATE AND  
12 EFFECTIVE FOR CONVEYING THE INFORMATION;

13                   (III) DISTRIBUTE INFORMATIONAL MATERIALS FREE OF  
14 CHARGE TO HEALTH CLINICS AND TO ESTABLISHMENTS OR ORGANIZATIONS  
15 THAT SERVE THE TARGETED POPULATION; AND

16                   (IV) INCLUDE ANY OTHER MATTER THAT THE STATE  
17 SUPERINTENDENT CONSIDERS APPROPRIATE.

18                   (B) TO CARRY OUT THIS SECTION, THE STATE SUPERINTENDENT:

19                   (1) ON REQUEST, SHALL RECEIVE AID OR INFORMATION FROM  
20 ANY AGENCY OF THIS STATE, OR FROM A POLITICAL SUBDIVISION;

21                   (2) MAY REQUEST THE SERVICES OF INTERESTED ADVOCACY  
22 GROUPS; AND

23                   (3) MAY CONTRACT FOR ANY NECESSARY SERVICES.

24                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
25 July 1, 2007.
