CHAPTER _____

1 AN ACT concerning

2 **Higher Education – St. Mary’s College of Maryland – Procurement Authority**

3 FOR the purpose of clarifying that St. Mary’s College of Maryland is exempt from
4 certain provisions of State procurement law; clarifying that certain procurement
5 policies and procedures of the College are subject to review and approval by the
6 Board of Public Works and the Administrative, Executive, and Legislative
7 Review Committee of the General Assembly; clarifying that certain
8 procurement policies and procedures of the College shall promote certain
9 purposes; and generally relating to the procurement authority of St. Mary’s
10 College of Maryland.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
10 MARYLAND, That the Laws of Maryland read as follows:

11 **Article – Education**

12 12–112.

13 (a) (1) Except as provided in § 11–203(e) of the State Finance and
14 Procurement Article, the University is exempt from Division II of the State Finance
15 and Procurement Article.

16 (2) (i) Subject to review and approval by the Board of Public Works
17 and the Administrative, Executive, and Legislative Review Committee of the General
18 Assembly, the Board of Regents shall develop policies and procedures governing
19 procurements by the University.

20 (ii) The policies and procedures developed under subparagraph
21 (i) of this paragraph shall promote the purposes of the State procurement law as set
22 forth in § 11–201 of the State Finance and Procurement Article.

24 (b) (1) Except as provided in § 11–203(e) of the State Finance and
25 Procurement Article, the University is exempt from Division II of the State Finance
26 and Procurement Article.

27 (2) (i) Subject to review and approval by the Board of Public Works
28 and the Administrative, Executive, and Legislative Review Committee of the General
29 Assembly, the Board of Regents shall develop policies and procedures governing
30 procurements by the University.

1 (ii) The policies and procedures developed under subparagraph
2 (i) of this paragraph shall promote the purposes of the State procurement law as set
3 forth in § 11–201 of the State Finance and Procurement Article.

5 (f) (1) **EXCEPT AS PROVIDED IN § 11–203(E) OF THE STATE FINANCE**
6 **AND PROCUREMENT ARTICLE, THE COLLEGE IS EXEMPT FROM DIVISION II OF**
7 **THE STATE FINANCE AND PROCUREMENT ARTICLE.**

8 [(1)] (2) (I) Subject to review **AND APPROVAL** by the [Legislative
9 Policy Committee] **BOARD OF PUBLIC WORKS AND THE ADMINISTRATIVE,**
10 **EXECUTIVE, AND LEGISLATIVE REVIEW COMMITTEE** of the General Assembly, the
11 Board of Trustees shall [establish procurement standards and procedures for the
12 College] **DEVELOP POLICIES AND PROCEDURES GOVERNING PROCUREMENTS BY**
13 **THE COLLEGE.**

14 (II) **THE POLICIES AND PROCEDURES DEVELOPED UNDER**
15 **SUBPARAGRAPH (I) OF THIS PARAGRAPH SHALL PROMOTE THE PURPOSES OF**
16 **THE STATE PROCUREMENT LAW AS SET FORTH IN § 11–201 OF THE STATE**
17 **FINANCE AND PROCUREMENT ARTICLE.**

18 [(2) The Board shall notify the Legislative Policy Committee of any
19 subsequent substantive changes to the standards and procedures established under
20 this subsection.]

21 **Article – State Finance and Procurement**

22 11–203.

23 (e) (1) In this subsection, “University” means the University System of
24 Maryland, Morgan State University, or St. Mary’s College of Maryland.

25 (2) Except as otherwise provided in this subsection, this Division II
26 does not apply to the University System of Maryland, Morgan State University, or St.
27 Mary’s College of Maryland.

28 (3) (i) A procurement by a University shall comply with the
29 policies and procedures developed by the University and approved by the Board of
30 Public Works and the Administrative, Executive, and Legislative Review Committee of
31 the General Assembly in accordance with § 12–112 of the Education Article for the

1 University System of Maryland, § 14–109 of the Education Article for Morgan State
2 University, or § 14–405(f) of the Education Article for St. Mary’s College of Maryland.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
4 June 1, 2007.
