Academic Facilities Bonding Authority

- 3 FOR the purpose of approving certain projects for the acquisition, development, and 4 improvement of certain academic facilities for the University System of 5 Maryland; authorizing the University System of Maryland to issue bonds to 6 finance certain projects; providing that certain bonds are not a debt or 7 obligation of the State or any of it political subdivisions; altering the purpose of a previously authorized academic facility project for the College of Liberal Arts 8 9 at Towson University; and generally relating to academic facilities bonding authority. 10

- 12 Chapter 415 of the Acts of the General Assembly of 2006

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 MARYLAND, That:

16 In accordance with Section 19-102(d) of the Education Article of the (1)Annotated Code of Maryland, each of the following projects is approved as a project for 17 an academic facility, and the University System of Maryland may issue, sell, and 18 19 deliver bonds in the total principal amount of \$15,000,000 for the purposes of financing and refinancing the costs of these projects: 20

1 (i) New Journalism Building 2 **(B)** Coppin State University (Baltimore City) 3 New Physical Education Complex (i) 4 (2)In accordance with Section 19-102(d) of the Education Article of the 5 Annotated Code of Maryland, such system-wide capital facilities renewal projects for 6 the constituent institutions and centers of the University System of Maryland as are 7 authorized by the Board are hereby approved as projects for academic facilities, and 8 the University System of Maryland may issue, sell, and deliver bonds in the total 9 principal amount of \$15,000,000 for the purposes of financing and refinancing the 10 costs of those facilities renewal projects. The bonds issued under the authority of this Act do not create or 11 (3)constitute any indebtedness or obligation of the State or of any political subdivision 12 thereof except the University System of Maryland, and the bonds shall so state on 13 14 their face. The bonds do not constitute a debt or obligation contracted by the General 15 Assembly of Maryland or pledge the faith and credit of the State within the meaning 16 of Article III, Section 34 of the Maryland Constitution.
