CHAPTER _____

1 AN ACT concerning

2 **Shellfish Dealers – Licensure**

3 FOR the purpose of requiring a person who deals in shellfish to obtain a license issued
4 by the Department of Natural Resources; requiring the Department to adopt
5 certain regulations to define the species that are included as shellfish for certain
6 purposes; and generally relating to the licensure of shellfish dealers.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Natural Resources**

15 4–702.

1 (a) Except as provided in subsection (b), a person may not buy, sell, ship,
2 transport, or otherwise deal in finfish **OR SHELLFISH** unless the person is licensed by
3 the Department.

4 (b) The following persons are not required to obtain a license under this
5 section:

6 (1) A person licensed by the Department to catch finfish for sale;

7 (2) A retail market, restaurant, or other establishment where finfish
8 are sold or served to ultimate consumers, and not for resale;

9 (3) A person who buys finfish for personal use or consumption; and

10 (4) A person who catches and sells as bait finfish species defined as
11 bait under subsection (c) of this section.

12 (c) The Department shall adopt regulations defining which species of finfish
13 may be caught and sold as bait under subsection (b)(4) of this section.

14 **(D) THE DEPARTMENT SHALL ADOPT REGULATIONS TO DEFINE THE**
15 **SPECIES THAT ARE INCLUDED AS SHELLFISH UNDER SUBSECTION (A) OF THIS**
16 **SECTION.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 July 1, 2007.
