4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2005
5 to extend the deadline by which the Board of Directors of Sotterley Foundation,
6 Inc. must present evidence to the Board of Public Works that a matching fund
7 will be provided.

9 Chapter 445 of the Acts of the General Assembly of 2005

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

1 (3) ZA01 LOCAL HOUSE OF DELEGATES INITIATIVES

2 (BM) Sotterley Plantation. Provide a grant equal to the lesser
3 of (i) \$50,000 or (ii) the amount of the matching fund
4 provided, to the Board of Directors of Sotterley
5 Foundation, Inc. for the planning, design, acquisition,
6 construction, installation, and capital equipping of
7 security upgrades for Sotterley Plantation, located in
8 Hollywood, subject to a requirement that the grantee
9 grant and convey an historic easement to the Maryland
10 Historical Trust. Notwithstanding Section 1(5) of this
11 Act, the matching fund may consist of in kind
12 contributions **AND THE GRANTEE MUST PRESENT**
13 **EVIDENCE THAT A MATCHING FUND WILL BE**
14 **PROVIDED BY JUNE 1, 2009** (St. Mary's County)..... 50,000

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 June 1, 2007.
