- 3 (g) The Department of Legislative Services shall provide staff for the Task 4 Force.
- 5 (h) A member of the Task Force:
- 6 (1) may not receive compensation **AS A MEMBER OF THE TASK** 7 **FORCE**; but
- 8 (2) is entitled to reimbursement for expenses under the Standard 9 State Travel Regulations, as provided in the State budget.

- (j) The Task Force shall submit an interim report to the Governor and the General Assembly, on or before December 1, [2006] **2007**, and report its final findings and recommendations to the Governor and, in accordance with § 2–1246 of the State Government Article, the General Assembly, on or before December 1, [2007] **2008**.
- SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2006. Section 3 of this Act shall remain effective for a period of [1 year, 6 months and 1 day] **3 YEARS** and, at the end of [December 1, 2007] **MAY 31, 2009**, with no further action required by the General Assembly, Section 3 of this Act shall be abrogated and of no further force and effect.
