9 10	(f) The Task Force may request assistance and information from any government unit or other expert that the Task Force considers appropriate.
11 12	(g) The Department of Legislative Services shall provide staff for the Task Force.

3 4 5	(6) the feasibility of establishing regional outreach and advocacy centers around the State and using existing service centers as outreach and advocacy centers;

10 11	(9) any issue regarding benefits and assistance to veterans that the Task Force determines is necessary.
12 13 14 15	(j) The Task Force shall submit an interim report to the Governor and the General Assembly, on or before December 1, [2006] <b>2007</b> , and report its final findings and recommendations to the Governor and, in accordance with § 2–1246 of the State Government Article, the General Assembly, on or before December 1, [2007] <b>2008</b> .
16 17 18 19 20	SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2006. Section 3 of this Act shall remain effective for a period of [1 year, 6 months and 1 day] <b>3 YEARS</b> and, at the end of [December 1, 2007] <b>MAY 31, 2009</b> , with no further action required by the General Assembly, Section 3 of this Act shall be abrogated and of no further force and effect.
