## A BILL ENTITLED

1 AN ACT concerning

2 **Carroll County – Alcoholic Beverages – Sunday Sales for Hotels and**  
3 **Restaurants**

4 FOR the purpose of altering the hours for Sunday sales of alcoholic beverages in  
5 Carroll County for holders of Class B beer, wine and liquor licenses for hotels  
6 and restaurants; and generally relating to alcoholic beverages in Carroll  
7 County.

8 BY repealing and reenacting, without amendments,  
9 Article 2B – Alcoholic Beverages  
10 Section 6–201(a)(1) and 11–507(a)  
11 Annotated Code of Maryland  
12 (2005 Replacement Volume and 2006 Supplement)

13 BY repealing and reenacting, with amendments,  
14 Article 2B – Alcoholic Beverages  
15 Section 11–507(b)(2)(i)  
16 Annotated Code of Maryland  
17 (2005 Replacement Volume and 2006 Supplement)

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article 2B – Alcoholic Beverages**

21 6–201.

1 (a) (1) A Class B beer, wine and liquor license shall be issued by the  
2 license issuing authority of the county in which the place of business is located, and  
3 the license authorizes its holder to keep for sale and sell all alcoholic beverages at  
4 retail at any hotel or restaurant at the place described, for consumption on the  
5 premises or elsewhere, or as provided in this section.

6 11-507.

7 (a) This section applies only in Carroll County.

8 (b) (2) (i) Holders of "on-sale" licenses authorized under this article  
9 may sell, offer for sale, or dispense alcoholic beverages during the hours of 8 a.m. and  
10 1 a.m. the following day and no other hours. Holders of these licenses may not sell,  
11 offer to sell or dispense any alcoholic beverages on Sunday except:

12 1. When the holder of that license is open for business on  
13 Saturday at midnight the licensee may remain open until 1 a.m. the Sunday  
14 immediately following;

15 2. Holders of Class [B, C,] C and H beer, wine and  
16 liquor licenses may reopen and may sell alcoholic beverages on Sundays between the  
17 hours of 12 noon and 1 a.m. the following Monday; [and]

18 **3. HOLDERS OF CLASS B BEER, WINE AND LIQUOR**  
19 **LICENSES MAY REOPEN AND MAY SELL ALCOHOLIC BEVERAGES ON SUNDAYS**  
20 **BETWEEN THE HOURS OF 11 A.M. AND 1 A.M. THE FOLLOWING MONDAY; AND**

21 [3.] 4. Holders of Class B beer and light wine, 7-day  
22 licenses may conduct "on-sales" of alcoholic beverages on Sundays between the hours  
23 of 12 noon and 1 a.m. the following Monday.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
25 July 1, 2007.
