A BILL ENTITLED

1 AN ACT concerning

2 **Licensed Cosmetologists – Practice Allowed in Specified Places**

3 FOR the purpose of allowing licensed estheticians and nail technicians to provide
4 services outside a beauty salon under certain circumstances; allowing licensed
5 cosmetologists, estheticians, and nail technicians to practice and provide
6 services in certain medical services facilities under certain circumstances; and
7 generally relating to licensed cosmetologists, estheticians, and nail technicians.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Business Occupations and Professions**

16 5–605.

17 (a) Except as provided in §§ 5–302 and 5–303 of this title and subsection (b)
18 of this section, a person may not practice cosmetology, **PROVIDE ESTHETIC**
19 **SERVICES, OR PROVIDE NAIL TECHNICIAN SERVICES** in any place other than:

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



- 1 (1) a beauty salon that holds a beauty salon permit; or
- 2 (2) a barbershop that holds a barbershop permit issued under Title 4
3 of this article.

4 (b) (1) A licensed cosmetologist, **ESTHETICIAN, OR NAIL TECHNICIAN**
5 may practice cosmetology **AND PROVIDE SERVICES** in:

6 **(I) A FACILITY IN WHICH BEAUTIFICATION-ORIENTED**
7 **MEDICAL SERVICES, AUTHORIZED BY THE DEPARTMENT OF HEALTH AND**
8 **MENTAL HYGIENE, ARE PROVIDED;**

9 **(II) the residence of an individual confined to the residence by**
10 **reason of a physical or mental infirmity[,];**

11 **(III) [in] an assisted living facility as defined in § 19-1801 of the**
12 **Health – General Article[,];**

13 **(IV) [in] a hospice facility defined in § 19-901(c) of the Health –**
14 **General Article[,];**

15 **(V) [in] a nursing home as defined in § 19-1401(e) of the Health**
16 **– General Article[,]; or**

17 **(VI) [in] a hospital as defined in § 19-301 of the Health –**
18 **General Article or a similar institution[, by appointment, if:**

19 (i) the licensed cosmetologist is sponsored by a beauty salon
20 that holds a beauty salon permit; and

21 (ii) the patron is a customer of the beauty salon.

22 (2) An individual who holds a limited license to provide nail technician
23 services may provide nail technician services in a barbershop].

24 **(2) TO PRACTICE IN ANY OF THE LOCATIONS SPECIFIED IN THIS**
25 **SUBSECTION:**

26 **(I) THE LICENSED COSMETOLOGIST, ESTHETICIAN, OR NAIL**
27 **TECHNICIAN SHALL BE SPONSORED BY A BEAUTY SALON IN WHICH THE**

1 **COSMETOLOGIST, ESTHETICIAN, OR NAIL TECHNICIAN IS AUTHORIZED TO**
2 **PRACTICE;**

3 **(II) THE PATRON TO WHOM THE SERVICES ARE RENDERED**
4 **SHALL BE A CUSTOMER OF THE BEAUTY SALON; AND**

5 **(III) THE SERVICES SHALL BE RENDERED BY APPOINTMENT**
6 **THROUGH THE BEAUTY SALON.**

7 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
8 **October 1, 2007.**
