Student Health - Inhalant Abuse - Awareness Campaign and Education
 Requirements
 (Mackenzie's Law)

FOR the purpose of requiring the State Superintendent of Schools, in collaboration with the Department of Health and Mental Hygiene, to establish and promote in certain schools an information, awareness, and education campaign related to inhalant abuse; providing for the components of the campaign; authorizing the State Superintendent to use certain resources to carry out the provisions of this Act; requiring the State Board of Education to include the subject of inhalants and inhalant abuse in the curricula of the comprehensive health education program; requiring the State Board to submit a certain report to the General Assembly on or before a certain date; and generally relating to an awareness campaign and education requirements related to inhalant abuse.

13 14	(1) a copy of all written materials distributed by the State Board and the Department of Health and Mental Hygiene;
15 16	(2) statistics on inhalant abuse by Maryland students before and after the campaign;
17 18	(3) a summary of the manner in which the State Superintendent carried out the campaign;
19 20	(4) a description of how the subject of inhalants and inhalant abuse was included in the comprehensive health education program; and
21 22	(5) any other relevant information as determined by the State Board of Education.
23 24	SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2007.
