A BILL ENTITLED

1 AN ACT concerning

2 **Natural Resources – Black Bears – Establishment of Population in Each**
3 **County**

4 FOR the purpose of requiring the Secretary of Natural Resources to establish a
5 program to ensure that, by a certain date, a black bear population is introduced
6 into each county in the State; and generally relating to black bears in the State.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Natural Resources**

15 10–2A–06.

16 (a) The Secretary shall establish programs, including acquisition of land or
17 aquatic habitat or interests in the land or aquatic habitats, necessary for the
18 conservation of nongame, threatened, or endangered species of wildlife or plants. The
19 Secretary shall use all vested authority to carry out the provisions of this subsection.

1 (b) In carrying out programs authorized by this section, the Secretary shall
2 consult with the State Secretary of Agriculture and other states having a common
3 interest in particular species of nongame, endangered, or threatened species of wildlife
4 or plants. The Secretary may enter into agreements with federal agencies, other
5 states, political subdivisions of the State, or with individuals with respect to programs
6 designed to conserve nongame, endangered, or threatened species of wildlife or plants,
7 including agreements for administration and management established under this
8 section or utilized for conservation of nongame, endangered, or threatened species of
9 wildlife or plants.

10 (c) The Governor shall review other programs administered by the Governor
11 and utilize these programs in furtherance of the purposes of this subtitle. All State
12 departments and agencies, in consultation with and with the assistance of the
13 Secretary, shall utilize their authorities in furtherance of the purposes of this subtitle
14 by carrying out programs for the conservation of endangered species and threatened
15 species listed pursuant to § 10-2A-04(f) of this subtitle, and by taking any action
16 necessary to insure that actions authorized, funded, or carried out by them do not
17 jeopardize the continued existence of the endangered species or threatened species or
18 result in the destruction or modification of habitat of the species which is deemed by
19 the Secretary to be critical.

20 (d) **THE SECRETARY SHALL ESTABLISH A PROGRAM TO ENSURE THAT,**
21 **BY OCTOBER 1, 2014, A BLACK BEAR POPULATION IS INTRODUCED INTO EACH**
22 **COUNTY IN THE STATE.**

23 (e) The Secretary shall adopt regulations necessary to implement this
24 section.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2007.
