Maryland Military Department Center for Military History

- 3 FOR the purpose of establishing a Maryland Military Department Center for Military 4 History; establishing the Maryland Museum of Military History and the 5 Maryland Military Historical Research Center as components of the Center for Military History; providing for the staffing and duties of the Center for Military 6 7 History and its components; authorizing the Center for Military History to 8 assume title to certain abandoned property in a certain manner; and generally relating to the establishment of a Maryland Military Department Center for 9 10 Military History.

- 27 (2) BE AUTHORIZED TO ENGAGE IN FUND-RAISING ON BEHALF OF

- 1 (3) BE AUTHORIZED TO PROVIDE VOLUNTEERS TO SUPPORT
- 2 ACTIVITIES OF THE MARYLAND MILITARY DEPARTMENT CENTER FOR
- 3 MILITARY HISTORY WITHOUT PAY OR COMPENSATION, EXCEPT THAT THE
- 4 VOLUNTEERS SHALL BE ELIGIBLE FOR BENEFITS UNDER WORKERS'
- 5 COMPENSATION FOR INJURIES SUFFERED IN THE COURSE OF VOLUNTEER
- 6 WORK FOR THE MARYLAND MILITARY DEPARTMENT CENTER FOR MILITARY
- 7 HISTORY AS IF THEY WERE PAID EMPLOYEES OF THE STATE; AND
- 8 (4) BE AUTHORIZED TO USE OFFICE SPACE WITHIN FACILITIES OF
- 9 THE MARYLAND MILITARY DEPARTMENT, INDEPENDENT OF THE SPACE
- 10 ALLOTTED TO THE MARYLAND MILITARY DEPARTMENT CENTER FOR
- 11 MILITARY HISTORY ON A SPACE-AVAILABLE BASIS AT THE DISCRETION OF THE
- 12 **ADJUTANT GENERAL.**

(F) THE MARYLAND MUSEUM OF MILITARY HISTORY SHALL:

- 14 (1) COLLECT, PRESERVE, INTERPRET, AND PRESENT
- 15 SIGNIFICANT ARTIFACTS AND ARTWORK RELATING TO THE HISTORY OF THE
- 16 PEOPLE, PLACES, AND EVENTS THAT REPRESENT ALL COMPONENTS AND
- 17 BRANCHES OF EACH SERVICE OF THE UNITED STATES MILITARY AND THE
- 18 MILITARY HERITAGE OF THE STATE; AND
- 19 (2) CONVEY AN AWARENESS OF THE MILITARY SERVICE OF
- 20 MARYLANDERS AND HOW THAT SERVICE HAS HELPED PRESERVE AMERICAN
- 21 FREEDOMS THROUGH EXHIBITS, EDUCATIONAL PROGRAMS, AND OUTREACH.
- 22 (G) THE MARYLAND MILITARY HISTORICAL RESEARCH CENTER

- 24 (1) COLLECT, INTERPRET, PRESERVE, AND PRESENT
- 25 DOCUMENTS, PHOTOGRAPHS, ELECTRONIC MEDIA, AND OTHER MATERIALS
- 26 CONTAINING INFORMATION OR IMAGERY RELATING TO THE HISTORY OF THE
- 27 PEOPLE, PLACES, AND EVENTS THAT REPRESENT ALL COMPONENTS AND
- 28 BRANCHES OF EACH SERVICE OF THE UNITED STATES MILITARY AND THE
- 29 **MILITARY HERITAGE OF THE STATE**;
- 30 (2) EDUCATE THE PUBLIC REGARDING THE MILITARY HISTORY OF
- 31 THE STATE BY PROVIDING BONA FIDE RESEARCHERS WITH ACCESS TO

- 3 (3) ADVISE THE ADJUTANT GENERAL AND THE MARYLAND
- 4 MILITARY DEPARTMENT GENERALLY ON MATTERS RELATING TO THE
- 5 HERALDRY, HONORS, LINEAGE, AND HISTORY OF UNITS OF THE ORGANIZED
- 6 MILITIA OF THE STATE.
- 7 (H) (1) THE MARYLAND MILITARY DEPARTMENT CENTER FOR
- 8 MILITARY HISTORY MAY ASSUME TITLE TO ABANDONED PROPERTY IN ITS
- 9 **POSSESSION.**
- 10 (2) PROPERTY SHALL BE CONSIDERED ABANDONED IF:
- 11 (I) IT HAS BEEN IN THE POSSESSION OF THE MARYLAND
- 12 MILITARY DEPARTMENT CENTER FOR MILITARY HISTORY FOR 7 YEARS OR
- 13 **MORE**;
- 14 (II) THERE ARE NO KNOWN OWNERS, OR A REASONABLE
- 15 ATTEMPT HAS BEEN MADE TO CONTACT THE OWNER WITHOUT SUCCESS, OR THE
- 16 OWNER HAS BEEN CONTACTED BUT HAS REFUSED TO TAKE POSSESSION OF THE
- 17 **PROPERTY**;
- 18 (III) THERE ARE NO KNOWN AGREEMENTS TO DONATE OR
- 19 LEND THE PROPERTY, OR THERE IS A KNOWN AGREEMENT TO LEND THE
- 20 PROPERTY FOR A FINITE PERIOD BUT THE PERIOD OF THE LOAN HAS BEEN
- 21 EXCEEDED BY 7 OR MORE YEARS, OR THERE IS AN AGREEMENT TO LEND THE
- 22 PROPERTY FOR AN INDEFINITE PERIOD BUT THE LENDER HAS BEEN DECEASED
- 23 FOR 7 OR MORE YEARS, OR THE PROPERTY WAS LENT BY AN ORGANIZATION
- 24 THAT HAS BEEN DEFUNCT FOR 7 OR MORE YEARS; AND
- 25 (IV) A NOTICE IS POSTED IN LOCAL NEWSPAPERS FOR AT
- 26 LEAST 2 WEEKS STATING THE INTENT TO TAKE TITLE TO THE PROPERTY IF IT IS
- 27 NOT CLAIMED AND THE OWNER OF THE PROPERTY DOES NOT CONTACT THE
- 28 MARYLAND MUSEUM OF MILITARY HISTORY WITHIN 1 WEEK OF THE FINAL
- 29 PUBLICATION OF THE NOTICE.
- 30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 31 October 1, 2007.
