A BILL ENTITLED

1 AN ACT concerning

2 **Veterinarians – Licenses – Waiver of Requirements**

3 FOR the purpose of authorizing the State Board of Veterinary Medical Examiners to
4 waive a certain license requirement of continuous practice for an applicant who
5 had been relocated outside the United States under certain circumstances;
6 requiring an applicant to submit certain proof to the Board; and generally
7 relating to the licensing of veterinarians in the State.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article – Agriculture**

16 **2–307.1.**

17 (A) **THIS SECTION APPLIES TO AN APPLICANT FOR A LICENSE TO**
18 **PRACTICE VETERINARY MEDICINE IN THE STATE IF THE APPLICANT:**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (1) **HAS AN ACTIVE VETERINARY LICENSE FROM ANOTHER STATE;**
2 **AND**

3 (2) **IS UNABLE TO MEET THE REQUIREMENTS OF THE BOARD DUE**
4 **TO A RELOCATION OUTSIDE THE UNITED STATES THAT RESULTED FROM**
5 **GOVERNMENT SERVICE OF THE APPLICANT OR THE APPLICANT'S SPOUSE.**

6 (b) **THE BOARD SHALL WAIVE THE REQUIREMENT FOR CONTINUOUS**
7 **CLINICAL PRACTICE OF VETERINARY MEDICINE FOR THE 5-YEAR PERIOD**
8 **PRECEDING THE DATE OF APPLICATION IF THE APPLICANT MEETS THE**
9 **REQUIREMENTS UNDER THIS SECTION.**

10 (c) **IN ORDER TO MEET THE REQUIREMENTS UNDER THIS SECTION, THE**
11 **APPLICANT SHALL SUBMIT TO THE BOARD PROOF OF:**

12 (1) **GOVERNMENT SERVICE AND RESIDENCY OUTSIDE THE**
13 **UNITED STATES; AND**

14 (2) **AN ACTIVE VETERINARY LICENSE FROM ANOTHER STATE.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 July 1, 2007.
