1 (2)"Facilities" means hospitals and related institutions whose rates 2 have been approved by the Commission. 3 (b) The Commission shall assess and collect user fees on facilities as defined 4 in this section. 5 (c) (1)The total fees assessed by the Commission may not exceed 6 [\$4,000,000] **\$5,000,000**. The total user fees assessed by the Commission may not exceed the 7 (2)8 Special Fund appropriation for the Commission by more than 20%. 9 The user fees assessed by the Commission shall be used exclusively (3)to cover the actual documented direct costs of fulfilling the statutory and regulatory 10 11 duties of the Commission in accordance with the provisions of this subtitle. The Commission shall pay all funds collected from fees assessed in 12 (4)accordance with this section into the Health Services Cost Review Commission Fund. 13 14 The user fees assessed by the Commission may be expended only (5)for purposes authorized by the provisions of this subtitle. 15 16 (6) The percentage amount by which total user fees assessed by the Commission under this section are increased from one fiscal year to the next may not 17 18 exceed the percentage amount by which the annual update factor applicable to all Maryland general acute care hospitals is increased for the same fiscal year. 19 20 (7)The amount specified in paragraph (1) of this subsection limits 21 only the total user fees the Commission may assess in a fiscal year. 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2007. 23
