- 2 (c) (1) The total fees assessed by the Commission may not exceed 3 [\$10,000,000] **\$12,000,000**.
  - (2) The fees assessed by the Commission shall be used exclusively to cover the actual documented direct costs of fulfilling the statutory and regulatory duties of the Commission in accordance with the provisions of this subtitle. [For the fiscal year 2007, the] **THE** costs of the Commission include the administrative costs incurred by the Department on behalf of the Commission. The amount to be paid by the Commission to the Department for administrative costs, not to exceed 18% of the salaries of the Commission, shall be based on indirect costs or services benefiting the Commission, less overhead costs paid directly by the Commission.
- 12 (3) The Commission shall pay all funds collected from the fees 13 assessed in accordance with this section into the Fund.
- 14 (4) The fees assessed may be expended only for purposes authorized by 15 the provisions of this subtitle.
- 16 (5) The amount in paragraph (1) of this subsection limits only the total 17 fees the Commission may assess in a fiscal year.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2007.
