#### **Article – State Government**

4 15–701.

5 (a) Unless exempted under subsection (b) of this section, an entity shall 6 register with the Ethics Commission as provided in this subtitle, and shall be a 7 "regulated lobbyist" for the purposes of this title, if, during a reporting period, the 8 entity:

9 (1) for the purpose of influencing any legislative action or, as to the 10 development or adoption of regulations or the development or issuance of an executive 11 order, executive action:

(i) 1. communicates with an official or employee of the
 Legislative Branch or Executive Branch in the presence of that official or employee;
 and

15 2. exclusive of the personal travel or subsistence 16 expenses of the entity or a representative of the entity, incurs expenses of at least 17 \$500 or earns at least \$2,500 as compensation for all such communication and 18 activities relating to the communication during the reporting period; or

19 (ii) 1. communicates with an official or employee of the
20 Legislative Branch or Executive Branch; and

21 2. earns at least \$5,000 as compensation for all such
22 communication and activities relating to the communication during the reporting
23 period;

(2) in connection with or for the purpose of influencing any executive
action, spends a cumulative value of at least \$100 for gifts, including meals, beverages,
and special events, to one or more officials or employees of the Executive Branch;

(3) subject to subsection (b)(4) of this section, is compensated to
 influence executive action on a procurement contract that exceeds \$100,000;

1 (4) subject to subsection (b)(5) of this section, is compensated by a 2 business entity to influence executive action to secure from the State a business grant 3 or loan with a value of more than \$100,000 for the business entity;

4 (5) spends at least \$2,000, including expenditures for salaries, 5 contractual employees, postage, telecommunications services, electronic services, 6 advertising, printing, and delivery services for the express purpose of soliciting others 7 to communicate with an official to influence legislative action or executive action; or

8 (6) spends at least \$2,500 to provide compensation to one or more 9 entities required to register under this subsection.

11 (f) (3) (i) Subject to subparagraphs (ii) and (iii) of this paragraph, if a 12 regulated lobbyist is or becomes subject to regulation under this title as an official or 13 employee, the regulated lobbyist shall immediately terminate the registration in 14 accordance with paragraph (2) of this subsection.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect16 October 1, 2007.
