- 8 (a) The provisions of this section apply only in Frederick County.
- 9 (I) (1) NOTWITHSTANDING THE RESTRICTIONS IN THIS SECTION AND IN § 7–101(G) OF THIS ARTICLE, THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE A ONE–DAY SPECIAL CLASS C BEER AND LIGHT WINE LICENSE AND A ONE–DAY SPECIAL CLASS C BEER, WINE AND LIQUOR LICENSE TO HOLY FAMILY CATHOLIC COMMUNITY.
