5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
6 MARYLAND, That Section(s) 8–211(i) of Article 2B – Alcoholic Beverages of the
7 Annotated Code of Maryland be renumbered to be Section(s) 8–211(j).

8 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
9 read as follows:

10 **Article 2B – Alcoholic Beverages**

11 8–211.

12 (a) The provisions of this section apply only in Frederick County.

13 (I) (1) **NOTWITHSTANDING THE RESTRICTIONS IN THIS SECTION AND**
14 **IN § 7–101(G) OF THIS ARTICLE, THE BOARD OF LICENSE COMMISSIONERS MAY**
15 **ISSUE A ONE–DAY SPECIAL CLASS C BEER AND LIGHT WINE LICENSE AND A**
16 **ONE–DAY SPECIAL CLASS C BEER, WINE AND LIQUOR LICENSE TO HOLY FAMILY**
17 **CATHOLIC COMMUNITY.**

18 (2) **ALL NET PROCEEDS FROM THE SALE OF ALCOHOLIC**
19 **BEVERAGES FOR HOLY FAMILY CATHOLIC COMMUNITY UNDER PARAGRAPH (1)**
20 **OF THIS SUBSECTION SHALL BE USED TO FUND BUILDING CONSTRUCTION OR**
21 **FOR CHARITABLE PURPOSES.**

22 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 June 1, 2007.
