14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 3 (B) "ADVISORY BOARD" MEANS THE MARYLAND LIFE SCIENCES 4 ADVISORY BOARD.
- "LIFE SCIENCES" INCLUDES THE FIELDS OF BIOTECHNOLOGY, 5 PHARMACEUTICALS, 6 BIOMEDICAL TECHNOLOGIES, LIFE **SYSTEMS** 7 SCIENCES, TECHNOLOGIES, **FOOD ENVIRONMENTAL** SCIENCES. AND 8 BIOMEDICAL DEVICES.

- 10 (A) THERE IS A MARYLAND LIFE SCIENCES ADVISORY BOARD IN THE 11 DEPARTMENT.
- 12 (B) (1) THE ADVISORY BOARD SHALL CONSIST OF 15 INDIVIDUALS, 13 ONE OF WHOM SHALL BE THE SECRETARY.
- 14 **(2)** THE REMAINING MEMBERS OF THE ADVISORY BOARD SHALL 15 BE APPOINTED BY THE GOVERNOR.
- 16 **(C) OF THE 14 APPOINTED MEMBERS:**
- 17 (1) THREE SHALL REPRESENT FEDERAL AGENCIES LOCATED IN THE STATE WITH LIFE SCIENCES MISSIONS;
- 19 **(2) FOUR SHALL HAVE EXECUTIVE EXPERIENCE IN LIFE** 20 **SCIENCES BUSINESSES**;
- 21 (3) FOUR SHALL REPRESENT COLLEGES OR UNIVERSITIES; AND
- 22 (4) THREE SHALL BE MEMBERS OF THE GENERAL PUBLIC.
- 23 **(D) A MEMBER OF THE ADVISORY BOARD MAY NOT RECEIVE** 24 **COMPENSATION AS A MEMBER OF THE ADVISORY BOARD, BUT IS ENTITLED TO**
- 25 REIMBURSEMENT FOR EXPENSES UNDER THE STANDARD STATE TRAVEL
- 26 REGULATIONS, AS PROVIDED IN THE STATE BUDGET.

- 1 (E) (1) EXCEPT FOR THE SECRETARY, THE TERM OF AN ADVISORY 2 BOARD MEMBER IS 2 YEARS.
- 3 (2) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE 4 UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.
- 5 (3) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN 6 SERVES ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS 7 APPOINTED AND QUALIFIES.
- 8 (F) THE GOVERNOR MAY REMOVE AN ADVISORY BOARD MEMBER FOR 9 INCOMPETENCE, MISCONDUCT, OR FAILURE TO PERFORM THE DUTIES OF THE 10 POSITION.
- 11 (G) A CHAIR SHALL BE SELECTED BY THE GOVERNOR FROM AMONG 12 THE ADVISORY BOARD MEMBERS.
- 13 (H) THE ADVISORY BOARD MAY ACT WITH AN AFFIRMATIVE VOTE OF 14 EIGHT MEMBERS.
- 15 (I) THE ADVISORY BOARD SHALL ASSIST THE DEPARTMENT IN:
- 16 **(1) DEVELOPING A COMPREHENSIVE STATE STRATEGIC PLAN**17 **FOR LIFE SCIENCES**;
- 18 (2) PROMOTING LIFE SCIENCES RESEARCH, DEVELOPMENT, 19 COMMERCIALIZATION, AND MANUFACTURING IN THE STATE;
- 20 **(3)** PROMOTING COLLABORATION AND COORDINATION AMONG 21 LIFE SCIENCES ORGANIZATIONS IN THE STATE;
- 22 (4) DEVELOPING A STRATEGY TO COORDINATE STATE AND 23 FEDERAL RESOURCES TO ATTRACT PRIVATE SECTOR INVESTMENT AND JOB 24 CREATION IN THE LIFE SCIENCES;
- 25 **(5) DEVELOPING A STRATEGY TO SUPPORT FEDERAL LIFE**26 **SCIENCES FACILITIES LOCATED IN THE STATE, INCLUDING SUPPORT FOR**27 **EDUCATION, TRANSPORTATION, HOUSING, AND CAPITAL INVESTMENT NEEDS;**28 **AND**

- 5 (A) THE ADVISORY BOARD SHALL REPORT TO THE GOVERNOR AND, IN
  6 ACCORDANCE WITH § 2–1246 OF THE STATE GOVERNMENT ARTICLE, TO THE
  7 GENERAL ASSEMBLY ON OR BEFORE DECEMBER 15 OF EACH YEAR.
- 8 (B) THE REPORT SHALL SET FORTH ANY RECOMMENDATIONS FROM
  9 THE ADVISORY BOARD AND SUMMARIZE THE ADVISORY BOARD'S ACTIVITIES
  10 DURING THE PRECEDING YEAR.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2007.
