Oral Health Safety Net Program

3 FOR the purpose of establishing the Oral Health Safety Net Program in the Office of Oral Health in the Department of Health and Mental Hygiene; providing for the 4 5 purpose of the Program; requiring the Office to solicit certain proposals; and 6 requiring the Office to award certain grants and oversee the operation of the 7 Program, subject to the limitations of the State budget; requiring the Office to 8 oversee the operation of the Program; requiring the Office to conduct a certain 9 annual evaluation of the Program; requiring the Office to contract with a certain individual, subject to the limitations of the State budget; requiring the 10 Office to provide certain education courses, subject to the limitations of the 11 State budget; requiring the Office to submit a certain report to the Governor 12 and to the General Assembly on or before a certain date each year; declaring the 13 intent of the General Assembly; requiring the Department to conduct a certain 14 15 survey; requiring the Secretary of Health and Mental Hygiene to submit a 16 certain report to the General Assembly on a certain date; defining a certain term; providing for the termination of this Act; and generally relating to oral 17 18 health for underserved populations in the State.

1 (b) The report required under subsection (a) of this section shall be 2 submitted to the General Assembly on or before December 1, 2007.

SECTION 2. 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2007. It shall remain effective for a period of 4 years and, at the end of September 30, 2011, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
