- (a) (1) A Class D beer and light wine license shall be issued by the license issuing authority of the county in which the place of business is located. The license authorizes its holder to keep for sale and to sell beer and light wines at retail, at the place described in the license, for consumption on the premises or elsewhere. The license may not be issued for any drugstore.

  (u) In Somerset County the annual license fee is [\$220] \$253.

- 8 (a) (1) A Class B beer, wine and liquor license shall be issued by the license issuing authority of the county in which the place of business is located, and the license authorizes its holder to keep for sale and sell all alcoholic beverages at retail at any hotel or restaurant at the place described, for consumption on the premises or elsewhere, or as provided in this section.
- 13 (u) (1) This subsection applies only in Somerset County.
- 14 (2) The annual license fee is [\$1,100] **\$1,265** for a restaurant or for a 15 hotel.

- 17 (a) (1) Except as provided in subsection (n) of this section, a Class C beer, 18 wine and liquor license shall be issued by the license issuing authority of the county in 19 which the place of business is located.
