4 FOR the purpose of providing that certain members of the State Retirement and Pension System may request the Executive Director of the State Retirement 5 Agency to take a certain action with regard to certain claims; authorizing the 6 7 Executive Director of the State Retirement Agency to accept or deny certain 8 requests by certain members; requiring the Board of Trustees of the State 9 Retirement and Pension System to review certain claims that have been denied by the Executive Director of the State Retirement Agency; authorizing the 10 11 Board of Trustees to overturn certain denials made by the Executive Director of 12 the State Retirement Agency; requiring the Board of Trustees to submit certain reports to the Joint Committee on Pensions on or before a certain date; 13 requiring the Board of Trustees to adopt certain regulations; providing that 14 certain members of the Employees' Pension System may transfer certain service 15 credit from the State Contributory Employees' Pension System in a certain 16 17 manner; requiring that certain members of the Employees' Pension System who 18 transfer certain service credit from the State Contributory Employees' Pension 19 System complete and file certain forms with the Board of Trustees of the State 20 Retirement and Pension System by a certain date; defining a certain term; providing for the termination of certain provisions of this Act; and generally 21

ON OR BEFORE OCTOBER 1 OF EACH YEAR, THE BOARD OF 1 **(C)** TRUSTEES SHALL SUBMIT A REPORT TO THE JOINT COMMITTEE ON PENSIONS 2 IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE, THAT 3 4 **PROVIDES:** 5 (1) THE NUMBER OF REQUESTS MADE BY INDIVIDUALS TO THE 6 **EXECUTIVE DIRECTOR REQUESTING A WAIVER OF THE 1-YEAR REQUIREMENT** 7 TO CLAIM TRANSFERRED SERVICE CREDIT: 8 (2) THE NUMBER OF REQUESTS GRANTED AND DENIED BY THE 9 **EXECUTIVE DIRECTOR; AND** 10 (3) THE NUMBER OF REQUESTS GRANTED BY THE BOARD OF TRUSTEES FOLLOWING A DENIAL BY THE EXECUTIVE DIRECTOR. 11 THE BOARD OF TRUSTEES SHALL ADOPT REGULATIONS TO CARRY 12 **(D) OUT THIS SECTION.** 13 SECTION 2. AND BE IT FURTHER ENACTED, That: 14 15 (a) In this section, "State Contributory Employees' Pension System" means the part of the Employees' Pension System of the State of Maryland that provides a 16 contributory pension benefit under Title 23, Subtitle 2, Part II of the State Personnel 17 and Pensions Article. 18 19 (b) This section applies to an individual who: 20 (1)on or before June 30, 2007, was employed by the Office of the 21 Public Defender and was a member of the State Contributory Employees' Pension 22 System: 23 on or after July 1, 2007, is employed by the State's Attorney's (2)Office for a county that: 24 25 is a participant in the Employees' Pension System as a (i) 26 participating governmental unit; and did not elect to participate in the contributory pension 27 (ii) 28 benefit under § 23-218 of the State Personnel and Pensions Article; and

1 (3) has been a member of the Employees' Pension System for more 2 than 1 year.

3 (c) (1) An individual described in subsection (b) of this section may elect 4 to transfer to the Employees' Pension System the years of creditable service the 5 individual accrued in the State Contributory Employees' Pension System prior to 6 joining the Employees' Pension System.

7 (2) An individual who elects to transfer creditable service in 8 paragraph (1) of this subsection shall transfer the creditable service in accordance 9 with Title 37 of the State Personnel and Pensions Article.

10 (d) To transfer service credit under subsection (c) of this section, an 11 individual shall complete a claim to transfer the service credit on a form provided by 12 the Board of Trustees for the State Retirement and Pension System and file it with the 13 Board of Trustees on or before December 31, 2007.

14 SECTION 2. 3. AND BE IT FURTHER ENACTED, That this Act shall take 15 effect July 1, 2007. It Section 2 of this Act shall remain effective for a period of 6 16 months and, at the end of December 31, 2007, with no further action required by the 17 General Assembly, Section 2 of this Act shall be abrogated and of no further force and 18 effect.
