1 2	(b) The governing body of Baltimore County may grant, by law, a property tax credit under this section against the county property tax imposed on:
3 4	(1) real property that is owned by the Twin River Protective and Improvement Association, Incorporated;
5 6	(2) real property that is owned by the Bowley's Quarters Improvement Association, Incorporated;
7 8	(3) real property that is owned by the Oliver Beach Improvement Association, Incorporated;
