2 **Maryland Audiologists, Hearing Aid Dispensers, and Speech-Language**
3 **Pathologists Act – Revision**

4 FOR the purpose of specifying that certain provisions of law apply to certain
5 individuals who practice audiology, hearing aid dispensing, or speech-language
6 pathology, or assist in the practice of speech-language pathology; ~~specifying~~
7 ~~that certain provisions of law do not authorize certain licensees to practice~~
8 ~~medicine, perform surgery, or prescribe pharmaceutical agents;~~ requiring
9 certain members of the State Board of Examiners for Audiologists, Hearing Aid
10 Dispensers, and Speech-Language Pathologists to currently practice in the
11 State; requiring a Board member to be a consumer of services provided by an
12 individual licensed by the Board; repealing the requirement that certain notice
13 and a certain balloting process be given by mail; altering certain qualifications
14 for certain members of the Board; providing that a majority of members
15 currently serving on the Board is a quorum; requiring the Board to appoint an
16 executive director; authorizing the Board to regulate the practice of telehealth
17 communications by audiologists, hearing aid dispensers, and speech-language
18 pathologists; repealing the authority of the Board to inspect facilities used by
19 licensed hearing aid dispensers; requiring the Board to adopt and publish a code
20 of ethics for the assistance of the practice of speech-language pathology;
21 authorizing the Board to require that certain licensed speech-language

1 pathology assistants submit to an examination by a certain health care provider
2 during certain investigations; requiring an individual to be licensed by the
3 Board before assisting in the practice of speech–language pathology; requiring
4 that on or before a certain date, certain individuals hired to practice
5 speech–language pathology or assist in the practice of speech–language
6 pathology by certain schools and educational institutions be licensed; exempting
7 certain individuals employed by certain schools or educational institutions
8 continuously since on or before a certain date from certain licensing
9 requirements; repealing a certain licensure exemption for individuals who fit
10 hearing aids; altering and adding speech–language pathology assistants to the
11 requirements for the authorization to practice without a license for certain
12 audiologists, hearing aid dispensers, and speech–language pathologists who are

20 practice of speech–language pathology; establishing the requirements for a

22 requirements for certain licensure examinations; altering the Board’s authority
23 to waive certain requirements for applicants for licenses to practice audiology
24 and speech–language pathology and establishing that the Board may waive
25 certain requirements for applicants for licenses to assist in the practice of
26 speech–language pathology; repealing a certain continuing education
27 requirement for certain individuals who are licensed to practice hearing aid
28 dispensing in a state that does not have certain continuing education
29 requirements; authorizing the Board to grant a waiver for an examination if an

11 a limited license to assist in the practice of speech–language pathology; altering
12 the requirement that the Board keep a record of certain business addresses
13 prohibiting a speech–language pathology assistant from surrendering a license
14 under certain circumstances; authorizing the Board to set conditions on certain
15 agreements with a speech–language pathology assistant who is under
16 investigation or while charges are pending; authorizing the Board to impose
17 certain penalties on speech–language pathology assistants under certain
18 circumstances; altering certain grounds for penalties; repealing a certain
19 exemption that allows a person to sell hearing aids by door–to–door solicitation
20 under certain circumstances; requiring audiologists and hearing aid dispensers
21 who sell hearing aids to provide certain refund information; altering certain
22 monetary penalties; authorizing the Board to issue subpoenas and administer
23 oaths under certain circumstances with the signature of an officer or
24 administrator of the Board; requiring licensees found in violation of certain
25 provisions to pay certain costs; establishing that a certain order of the Board
26 may not be stayed pending review; establishing one rehabilitation committee for

30 **CONSISTENT OR FAILS TO BE CONSISTENT WITH PROFESSIONAL STANDARDS**
31 **AND THE PROVISIONS OF THIS TITLE.**

1 [(d) “Fit hearing aids” means:

2 (1) Solely for the purposes of choosing, adapting, or selling hearing
3 aids or for the use of a member of a health occupation that has a professional concern
4 about human hearing, to measure human hearing by any means, including the
5 preparation of an audiogram by means of an audiometer and evaluation of the
6 audiogram;

7 (2) To make an impression of a human ear for the purpose of building
8 an ear mold; or

9 (3) To provide advice about the choice or use of a hearing aid by a
10 hearing impaired individual.]

21 **(G) “HEARING AID DISPENSER SUPERVISOR” MEANS A LICENSED**
22 **HEARING AID DISPENSER OR LICENSED AUDIOLOGIST WHO SUPERVISES A**
23 **LIMITED LICENSEE WHO IS STUDYING HEARING AID DISPENSING FOR THE**
24 **PURPOSE OF BECOMING ELIGIBLE TO SIT FOR THE LICENSURE EXAMINATION.**

25 **(H) (1) “HEARING AID DISPENSING” MEANS PERFORMING,**
26 **CONDUCTING, AND INTERPRETING HEARING ASSESSMENT PROCEDURES TO**
27 **DETERMINE THE TYPE AND EXTENT OF HEARING LOSS FOR THE PURPOSE OF:**

28 **(I) FITTING SUITABLE HEARING INSTRUMENTS;**

29 **(II) SELECTING SUITABLE HEARING INSTRUMENTS;**

14 **OFFERS, ADVERTISES, OR PERFORMS HEARING AID DISPENSING.**

16 **license issued by the Board to practice audiology, [to provide hearing aid services]**
17 **HEARING AID DISPENSING, or [to practice] speech–language pathology, OR TO**

25 **hearing aid services] PRACTICE HEARING AID DISPENSING.**

27 **requires otherwise, a speech–language pathologist who is licensed by the Board to**
28 **practice speech–language pathology.**

5 (2) **“SPEECH ASSISTANT”;**
6 (3) **“SPEECH-LANGUAGE ASSISTANT”;**
7 (4) **“SPEECH-LANGUAGE TEACHER”;** OR
8 (5) **“SPEECH TEACHER”.**

9 2-403.

10 A person may not knowingly make a false, material statement in an application
11 for a license or a limited license or for renewal of a license or a limited license.

12 2-404.

13 A person may not materially alter a license or a limited license with fraudulent
14 intent.

15 2-405.

16 A person may not transfer or offer to transfer a license or a limited license for
17 consideration.

18 2-406.

19 While providing hearing aid services as an audiologist or a hearing aid
20 dispenser, a person may not:

21 (1) Engage in an unfair or deceptive trade practice, as defined in
22 § 13-301 of the Commercial Law Article; or

23 (2) Violate any provision of Title 14, Subtitle 25 of the Commercial
24 Law Article.

25 2-408.

1 A person who violates any provision of this title is guilty of a misdemeanor and
2 on conviction is subject to a fine not exceeding [\$500] **\$5,000** or imprisonment not
3 exceeding [90 days] **3 YEARS** or both.

4 2-501.

5 This title may be cited as the “Maryland [Audiologists, Hearing Aid Dispensers,
6 and Speech–Language Pathologists] **AUDIOLOGY, HEARING AID DISPENSING, AND**
7 **SPEECH–LANGUAGE PATHOLOGY Act**”.

8 2-502.

9 Subject to the evaluation and reestablishment provisions of the Maryland
10 Program Evaluation Act, this title and all rules and regulations adopted under this
11 title shall terminate and be of no effect after July 1, 2016.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
13 October 1, 2007.
