1 AN ACT concerning

2 **Calvert County Board of Education – Compensation**

3 FOR the purpose of altering the compensation received by certain members of the
4 Calvert County Board of Education; providing that this Act does not apply to
5 the salary or compensation of the incumbent members of the Board; and
6 generally relating to the compensation received by members of the Calvert
7 County Board of Education.

1 Annotated Code of Maryland

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
4 MARYLAND, That the Laws of Maryland read as follows:

5 **Article – Education**

6 3–303.

7 (a) At its first meeting at the beginning of each calendar year, the County
8 Board shall elect a president and a vice president from among its members.

9 (b) (1) The president of the County Board is entitled to receive [\$5,000]
10 **\$6,500** annually as compensation and the other members are entitled to receive
11 ~~[\$4,000]~~ **\$5,500** each annually as compensation.

12 (2) An elected member is entitled to health insurance benefits
13 regularly provided to employees of the Board of Education under the same terms and
14 conditions extended to other employees of the Board of Education.

15 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
16 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
17 the salary or compensation of the *president and* members of the Calvert County Board
18 of Education in office on the effective date of this Act, but the provisions of this Act
19 concerning the salary or compensation of the *president and* members of the Calvert
20 County Board of Education shall take effect at the beginning of the next following
21 term of office.

22 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
23 October 1, 2007.
