## Wineries - Special Event Permits - Farmers' Markets

3 FOR the purpose of altering the number of winery special event permits that the 4 Comptroller may issue to Class 4 Maryland limited wineries in a calendar year 5 and in the same political subdivision; altering the number of certain bottles of wine that a permit holder may sell to a consumer at a certain event or festival 6 7 for consumption off the premises; authorizing the Comptroller to issue an 8 unlimited number of permits for use at certain farmers' markets; prohibiting a 9 permit holder to sell wine by the glass at a farmer's market; and generally 10 relating to winery special event permits.
