## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Baltimore County – Arbutus Community Center Loan of 2000**

3 FOR the purpose of extending the deadline by which the County Executive and County  
4 Council of Baltimore County must present evidence to the Board of Public  
5 Works that a matching fund will be provided.

6 BY repealing and reenacting, without amendments,

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
17 MARYLAND, That the Laws of Maryland read as follows:

3               SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
4 MARYLAND, That:

5               (1)     The Board of Public Works may borrow money and incur indebtedness on  
6 behalf of the State of Maryland through a State loan to be known as the Baltimore  
7 County – Arbutus Community Facility Loan of 2000 in a total principal amount equal  
8 to the lesser of (i) \$250,000 or (ii) the amount of the matching fund provided in  
9 accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale,  
10 and delivery of State general obligation bonds authorized by a resolution of the Board  
11 of Public Works and issued, sold, and delivered in accordance with §§ 8–117 through  
12 8–124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.

13              (5)     Prior to the payment of any funds under the provisions of this Act for  
14 purposes set forth in Section 1(3) above, the grantee shall provide and expend a  
15 matching fund. No part of the grantee’s matching fund may be provided, either  
16 directly or indirectly, from funds of the State, whether appropriated or  
17 unappropriated. No part of the fund may consist of real property, in kind  
18 contributions, or funds expended prior to the effective date of this Act. In case of any  
19 dispute as to the amount of the matching fund or what money or assets may qualify as  
20 matching funds, the Board of Public Works shall determine the matter and the  
21 Board’s final decision is final. The grantee has until June 1, [2006] **2009**, to present  
22 evidence satisfactory to the Board of Works that a matching fund will be provided. If  
23 satisfactory evidence is presented, the Board shall certify this fact and the amount of  
24 the matching fund to the State Treasurer, and the proceeds of the loan equal to the  
25 amount of the matching fund shall be expended for the purposes provided in this Act.  
26 Any amount of the loan in excess of the amount of the matching fund certified by the  
27 Board of Public Works shall be canceled and be of no further effect.

28              SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
29 June 1, 2007.
