4 FOR the purpose of ~~adding~~ *repealing* in Dorchester County ~~a certain type of certain~~  
5 *limitations on the types of certain* alcoholic beverages ~~license to the types of~~  
6 licenses that entitle premises to be issued additional Class A beer licenses;  
7 authorizing the Board of License Commissioners of Dorchester County to limit  
8 the number of additional Class A beer licenses that it issues; and generally  
9 relating to alcoholic beverages licenses in Dorchester County.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
 6 MARYLAND, That the Laws of Maryland read as follows:

7 **Article 2B – Alcoholic Beverages**

8 9–102.

9 (b–6) (1) Notwithstanding any other provision of this section, in Dorchester  
 10 County an additional Class A beer license may be issued for any premises licensed  
 11 under a Class B [beer license], ~~CLASS C~~, or Class D [beer license or beer, wine and  
 12 liquor] license.

13 (2) **THE BOARD OF LICENSE COMMISSIONERS OF DORCHESTER**  
 14 **COUNTY MAY LIMIT THE NUMBER OF ADDITIONAL CLASS A BEER LICENSES**  
 15 **THAT IT ISSUES.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 17 July 1, 2007.
