3 FOR the purpose of requiring an electric company, on written request of a certain electricity supplier, to give to the requesting electricity supplier certain 4 5 information regarding certain customers; requiring a certain list to contain certain information; requiring a certain list to be provided in electronic form 6 7 and to be updated quarterly; authorizing a certain electric company to request 8 that the Public Service Commission set a certain fee; requiring a certain electric 9 company to provide certain notice to certain customers at certain times; 10 providing for the contents of a certain notice; providing that a certain customer may withhold or withdraw permission for certain information to be released to 11 12 certain persons under certain circumstances; providing that a certain customer is deemed to have given a certain electric company permission to release certain 13 14 information to certain persons under certain circumstances; providing that a 15 certain electricity supplier may only use certain information for certain 16 purposes; prohibiting a certain electricity supplier from selling or transferring 17 certain information to any other person under certain circumstances; authorizing a certain electricity supplier to provide certain information to a 18 certain authorized agent for certain circumstances; and generally relating to the 19 20 release of customer information from an electric company to an electricity supplier. 21
