#### 1 AN ACT concerning

#### 2 **Education - Relocatable Classrooms - Indoor Air Quality Standards**

3 FOR the purpose of requiring the Board of Public Works, in consultation with the 4 Department of General Services and the Department of Housing and Community Development, to adopt regulations to establish certain standards 5 6 and specifications to enhance the indoor air quality of certain relocatable 7 classrooms; providing for the application of this Act; and generally relating to 8 regulations governing the indoor air quality of relocatable classrooms.

9 BY repealing and reenacting, without amendments,

(ii) The Board of Public Works, at the recommendation of the
Interagency Committee on School Construction, shall adopt regulations that:
1. Define modular construction; and
2. Establish the minimum specifications required for
approval of modular construction as a public school construction or capital
improvement cost.
(4) The cost of acquiring land may not be considered a construction or
capital improvement cost and may not be paid by the State.
SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
construed to apply only prospectively and may not be applied or interpreted to have
any effect on or application to any relocatable classrooms purchased or leased before
the effective date of this Act.
SECTION <del>2.</del> <u>3.</u> AND BE IT FURTHER ENACTED, That this Act shall take
effect October 1, 2007.
