1 AN ACT concerning

2 **Education - Relocatable Classrooms - Indoor Air Quality Standards**

3 FOR the purpose of requiring the Board of Public Works, in consultation with the
4 Department of General Services and the Department of Housing and
5 Community Development, to adopt regulations to establish certain standards
6 and specifications to enhance the indoor air quality of certain relocatable
7 classrooms; providing for the application of this Act; and generally relating to
8 regulations governing the indoor air quality of relocatable classrooms.

~~19 5. (5) REQUIRE EACH UNIT TO BE OUTFITTED WITH AN
20 ENERGY EFFICIENT LIGHTING AND HEATING AND AIR-CONDITIONING SYSTEM

~~22 6. (6) MANDATE THAT EACH UNIT BE CONSTRUCTED
23 WITH BUILDING MATERIALS THAT CONTAIN LOW AMOUNTS OF VOLATILE

~~25 [(iii)](IV) In the budgets for fiscal years 2006 through 2008, the
26 Governor shall include \$1,000,000 for public school construction, in excess of the
27 estimates of funding for public school construction contained in the fiscal year 2005
28 through fiscal year 2009 Capital Improvement Plan, to be used to fund the State share
29 of the cost of purchasing relocatable classrooms.~~

(3) (i) The Board of Public Works shall include modular construction as an approved public school construction or capital cost.

1 (ii) The Board of Public Works, at the recommendation of the
2 Interagency Committee on School Construction, shall adopt regulations that:

3 1. Define modular construction; and

4 2. Establish the minimum specifications required for
5 approval of modular construction as a public school construction or capital
6 improvement cost.

7 (4) The cost of acquiring land may not be considered a construction or
8 capital improvement cost and may not be paid by the State.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be
10 construed to apply only prospectively and may not be applied or interpreted to have
11 any effect on or application to any relocatable classrooms purchased *or leased* before
12 the effective date of this Act.

13 SECTION ~~2~~ 3. AND BE IT FURTHER ENACTED, That this Act shall take
14 effect October 1, 2007.
