Somerset and Queen Anne's Counties - Authorization to Harvest Seafood and **Engage in the Seafood Industry**

4 FOR the purpose of authorizing the governing bodies of Somerset County and Queen 5 Anne's County to adopt an ordinance, resolution, or regulation or take other 6 action to authorize a person to engage in certain activities related to the seafood 7 industry and to harvest seafood; clarifying that the governing body of the county 8 in which the ordinance, resolution, or regulation will apply is required to hold a 9 public hearing and obtain the written consent of the Secretary of Natural 10 Resources before adopting a certain ordinance, resolution, or regulation; providing that an ordinance, resolution, or regulation, adopted by a governing 11 12 body under this Act without written consent of the Secretary, is void; providing that in the event of a certain conflict, federal law, State law, or a certain written 13 14 program guidance preempts a certain ordinance, resolution, or regulation adopted by a governing body under this Act; making conforming changes; and 15 16 generally relating to the authority of the governing bodies of certain counties to 17 authorize a person to engage in certain activities related to the seafood industry and to harvest seafood. 18
