3 FOR the purpose of repealing a certain requirement to take a certain examination as 4 part of the application process for a senatorial scholarship; altering the 5 maximum amount of a certain award; repealing a certain condition relating to 6 the use of a certain award for summer school; repealing a certain deadline; 7 repealing a certain requirement for the Office of Student Financial Assistance 8 within the Maryland Higher Education Commission to make a certain 9 announcement; repealing a certain authorization for a certain appointment for 10 receipt of a certain scholarship; and generally relating to senatorial scholarships. 11
