CHAPTER _____

1 AN ACT concerning

2 **State Personnel – Compensatory Time for Mentoring Youth**

3 FOR the purpose of providing that certain State employees may be entitled to earn
4 compensatory time for mentoring youth in certain mentoring youth programs;
5 establishing the maximum number of hours of compensatory time that an
6 employee may earn for mentoring youth; requiring that the total value of
7 compensatory time awarded for mentoring youth may not exceed a certain
8 amount; authorizing an employee to mentor youth after obtaining approval from
9 the employee's appointing authority; requiring the Secretary of Budget and
10 Management to adopt certain regulations; providing for the application of this
11 Act; providing for the termination of this Act; and generally relating to
12 compensatory time for State employees mentoring youth.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

1 **Article – State Personnel and Pensions**

2 **8–310.**

3 **(A) THIS SECTION APPLIES TO ALL EMPLOYEES, EXCEPT TEMPORARY**
4 **EMPLOYEES, OF ALL UNITS IN THE EXECUTIVE BRANCH OF STATE**
5 **GOVERNMENT, INCLUDING ANY UNIT WITH AN INDEPENDENT PERSONNEL**
6 **SYSTEM.**

7 **(B) AN EMPLOYEE SUBJECT TO THIS SECTION SHALL BE ENTITLED TO**
8 **COMPENSATORY TIME FOR MENTORING YOUTH IN A BONA FIDE MENTORING**
9 **YOUTH PROGRAM.**

10 **(C) (1) AN EMPLOYEE MAY EARN UP TO 8 HOURS OF COMPENSATORY**
11 **TIME EVERY MONTH FOR MENTORING YOUTH.**

12 **(2) AN EMPLOYEE EARNING COMPENSATORY TIME FOR**
13 **MENTORING YOUTH MUST BE QUALIFIED TO MENTOR YOUTH, AS DETERMINED**
14 **BY THE SECRETARY.**

15 **(3) THE TOTAL VALUE OF COMPENSATORY TIME AWARDED FOR**
16 **MENTORING YOUTH MAY NOT EXCEED \$250,000 IN EACH FISCAL YEAR.**

17 **(D) AN EMPLOYEE MAY EARN COMPENSATORY TIME UNDER THIS**
18 **SECTION FOR MENTORING YOUTH AFTER OBTAINING APPROVAL FROM THE**
19 **EMPLOYEE’S APPOINTING AUTHORITY.**

20 **(E) THE SECRETARY SHALL ADOPT REGULATIONS THAT ESTABLISH**
21 **CONDITIONS AND PROCEDURES THAT ALLOW AN EMPLOYEE TO MENTOR YOUTH,**
22 **INCLUDING:**

23 **(1) REQUIREMENTS THAT THE EMPLOYEE MEET QUALIFICATIONS**
24 **FOR MENTORING YOUTH BEFORE THE EMPLOYEE IS APPROVED TO MENTOR**
25 **YOUTH; AND**

26 **(2) WHAT CONSTITUTES A BONA FIDE MENTORING YOUTH**
27 **PROGRAM.**

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2007. It shall remain effective for a period of 3 years and, at the end of
3 September 30, 2010, with no further action required by the General Assembly, this Act
4 shall be abrogated and of no further force and effect.
