A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City – Sheriff’s Office – Personnel and Salaries**

3 FOR the purpose of requiring the Sheriff of Baltimore City to appoint a certain
4 number of additional persons to certain positions in the Sheriff’s Office;
5 authorizing the Sheriff of Baltimore City to appoint up to a certain number of
6 additional persons to certain positions in the Sheriff’s Office; requiring that
7 certain employees in the Baltimore City Sheriff’s Office receive a salary not less
8 than the salary of certain employees of the Baltimore City Police Department;
9 and generally relating to personnel and salaries in the Baltimore City Sheriff’s
10 Office.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Article – Courts and Judicial Proceedings**

19 2–309.

20 (d) (1) (ii) The Sheriff:

1 1. Shall appoint an undersheriff or chief deputy sheriff,
2 [one] **TWO** assistant [sheriff] **SHERIFFS**, [two] **FIVE** deputy sheriff majors, [two]
3 **FOUR** deputy sheriff captains, [four] **EIGHT** deputy sheriff lieutenants, one secretary
4 sheriff, and one fiscal clerk sheriff; and

5 2. May appoint up to a maximum of:

6 A. [7] **16** deputy sheriff sergeants; and

7 B. [90] **106** deputy sheriffs.

8 (iii) 1. Except for deputy sheriffs, deputy sheriff sergeants,
9 and deputy sheriff lieutenants, salaries for these employees shall be set by the
10 Secretary of Budget and Management.

11 2. Salaries for deputy sheriffs shall be set at a rate not
12 less than the salary [equivalent to grade 14 of the State pay scale] **OF A BALTIMORE**
13 **CITY POLICE OFFICER WITH EQUAL SERVICE TIME.**

14 3. Salaries for deputy sheriff sergeants shall be set at a
15 rate not less than the salary [equivalent to grade 16 of the State pay scale] **OF A**
16 **BALTIMORE CITY POLICE SERGEANT WITH EQUAL SERVICE TIME.**

17 4. Salaries for deputy sheriff lieutenants shall be set at a
18 rate not less than the salary [equivalent to grade 18 of the State pay scale] **OF A**
19 **BALTIMORE CITY POLICE LIEUTENANT WITH EQUAL SERVICE TIME.**

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2007.
