- 3 FOR the purpose of requiring the Sheriff of Baltimore City to appoint a certain 4 number of additional persons to certain positions in the Sheriff's Office; 5 authorizing the Sheriff of Baltimore City to appoint up to a certain number of additional persons to certain positions in the Sheriff's Office; requiring that 6 certain employees in the Baltimore City Sheriff's Office receive a salary not less 7 8 than the salary of certain employees of the Baltimore City Police Department; and generally relating to personnel and salaries in the Baltimore City Sheriff's 9 10 Office.

1 2 3 4	1. Shall appoint an undersheriff or chief deputy sheriff, [one] TWO assistant [sheriff] SHERIFFS, [two] FIVE deputy sheriff majors, [two] FOUR deputy sheriff captains, [four] EIGHT deputy sheriff lieutenants, one secretary sheriff, and one fiscal clerk sheriff; and
5	2. May appoint up to a maximum of:
6	A. [7] <b>16</b> deputy sheriff sergeants; and
7	B. [90] <b>106</b> deputy sheriffs.
8 9 10	(iii) 1. Except for deputy sheriffs, deputy sheriff sergeants, and deputy sheriff lieutenants, salaries for these employees shall be set by the Secretary of Budget and Management.
11 12 13	2. Salaries for deputy sheriffs shall be set at a rate not less than the salary [equivalent to grade 14 of the State pay scale] <b>OF A BALTIMORE CITY POLICE OFFICER WITH EQUAL SERVICE TIME</b> .
14 15 16	3. Salaries for deputy sheriff sergeants shall be set at a rate not less than the salary [equivalent to grade 16 of the State pay scale] <b>OF A BALTIMORE CITY POLICE SERGEANT WITH EQUAL SERVICE TIME</b> .
17 18 19	4. Salaries for deputy sheriff lieutenants shall be set at a rate not less than the salary [equivalent to grade 18 of the State pay scale] <b>OF A BALTIMORE CITY POLICE LIEUTENANT WITH EQUAL SERVICE TIME</b> .
